Applicant's experience working with Job Corps eligible student populations: Terra State Community College has been serving students, including Job Corps eligible students, for 50 years and educates over 2,400 students annually.

List of previous personal/career and employment counseling services provided: initial intake and assessment; develop individualized education and employment plans; case management; wraparound services; crisis intervention; budgeting and money management; dual enrollment into WIOA or other community services; financial aid assistance; tutoring and mentoring; laboratory, workshop, and testing fees; supplies and materials including books and school supplies; transportation costs; meal or food vouchers; costs included in the program's cost of attendance, such as those in Section 472 the Higher Education Act of 1965; work supports and tools; childcare; cover letter and resume development; mock interviewing; job search assistance; LMI; work based learning, OJTs; job development and placement assistance; and retention and follow-up services.

## Brief summary of the proposed project, including, but not limited to, the scope of the project and proposed outcomes:

Terra' Job Corps Scholars initiative, in partnership with Great Lakes Community Action Partnership, will provide free tuition for career technical training. Career Coaches will provide intensive personal and career counseling services to support and facilitate completion of the program. In addition, employment counseling services will be provided, including a 12-month follow-up period of employment services which incorporates assistance in enrolling into an Apprenticeship program and/or job placement.
