

**NOTICE OF FUNDED STATUS
FOR
HAWAII STEVEDORING MULTIEMPLOYER PENSION PLAN**

The Plan, and the predecessor plans that merged to form it, has been providing benefits for Plan participants without interruption for decades. The Pension Committee remains committed to operating the Plan on a financially sound basis and meeting all Federal funding requirements.

In 2006, the Pension Protection Act (“PPA”) became law. Under the requirements of PPA, this is to inform you that on March 31, 2014 the Plan actuary certified to the U.S. Department of the Treasury, and the Plan sponsor, that the Hawaii Stevedoring Multiemployer Pension Plan (the “Plan”) falls in the category of “endangered” status for the Plan year beginning January 1, 2014. Federal law requires that you receive this notice.

“Endangered” Status. The Plan is considered to be in “endangered” status under the PPA because the Plan’s actuary has determined that the Plan’s funded percentage for 2014 is less than 80%, but that the Plan is sufficiently funded such that it is not in either the PPA categories of “seriously endangered” status or “critical” status. The fact that the Plan falls in the “endangered” category does not mean the Plan is failing or will fail in providing retirement benefits. It just means the funded status is not at least 80% at this time.

Funding Improvement Plan. In accordance with Federal law, the Pension Committee adopted a funding improvement plan (“FIP”) as of November 25, 2008 aimed at improving the funded status of the plan so that the Plan meets the applicable benchmarks established by PPA. The FIP was amended as of March 13, 2009 to reflect changes in the law enacted in the Worker, Retiree, and Employer Recovery Act on December 23, 2008. The Plan’s actuary updates the FIP annually as required and monitors the progress of the Plan’s funding to determine whether the requirements of the FIP are met during the FIP period (through December 31, 2021).
