PROBLEM TO BE ADDRESSED	At the time of project funding and since 1986, the Government of Uganda pursued a vigorous economic recovery program. Nevertheless, 55 percent of Ugandans lived below the government poverty line, equivalent to USD 4 a month. It is believed that poverty, combined with a high number of AIDS orphans and a lack of schooling opportunities, forced many children to work in exploitive and hazardous conditions in Uganda.
RESULTS	The project withdrew 3,376 children and prevented another 18 children from commercial sexual exploitation, street work, domestic work, and informal sector activities in Kampala; domestic work in Mpigi; and commercial agriculture in Kakira and Kinyara.
PROJECT OBJECTIVES	To contribute to the progressive elimination of exploitive child labor in Uganda, focusing on the prevention, withdrawal, rehabilitation, and provision of educational alternatives for working children.
	Intermediate objectives included:
	 At the end of the program, the Government of Uganda will have developed a national policy and plan of action to combat exploitive child labor, taken concrete measures towards the harmonization of its child labor legislation, and developed its institutional capacity to deal with this problem; and At the end of this program, a range of successful pilot projects will have been implemented, improving the situation of ex-child workers either directly or indirectly, and initiating a change of attitudes about child labor in Ugandan society.
