Together have we led a guided effort under the "Zero Tolerance for Child Labor Policy", which has been identified as a good practice nationally and internationally.

Our Zero Tolerance Policy entails the strict exclusion of workers under 18 years of age to be involved in the sugar crop's harvest and activities, as well as all the necessary mechanisms implemented to ensure compliance of said policy.

The Zero Tolerance Policy consists of the following 5 strategic pillars:


- 1. Permanent Awareness to strategic public
- 2. Standardization of actions carried out by the six sugar mills in the country, which includes three elements:
 - a. Specific clauses of the prohibition and termination of sugarcane purchase-sale contracts, due to hazardous child labor.
 - b. Action Protocol.
 - c. Human Resource specialized in the subject.
- 3. **Public-private alliances**, among the most relevant, we are members of the "National Committee for the Eradication of the Worst Forms of Child Labor".
- 4. **Permanent monitoring** during all months of the year.
- 5. Communication, we participate in various forums at an international level.

The Sugar Sector in El Salvador has been recognized worldwide by the International Labor Organization. We participated in the "III World Conference on Child Labor" in 2013, as speakers for the theme "Child Labor in the Supply Chain". The Conference was chaired and organized by the Government of Brazil, in collaboration with the International Labor Organization (ILO), which brought together more than 130 countries, represented by governments, workers' and employers' organizations, and civil society.





Through the implementation of the Zero Tolerance Policy in 2015, we have eradicated child labor. The most recent figures audited by our sector show a 99% decrease in the industry.



It is important to note that, from the beginning of the efforts to eradicate child labor in the sugar industry, awareness existed that said objective would require a permanent process, bearing in mind the need to provoke a cultural change in rural populations, as well as the need to create opportunity conditions for people's development.


