<b>PROJECT TITLE</b>	<b>SUPPORT TO NATIONAL EFFORTS TOWARD A CHILD LABOUR-FREE STATE, BAHIA - BRAZIL</b>
<b>REGION/COUNTRY</b>	THE AMERICAS/Brazil
<b>PROJECT DURATION</b>	September 30, 2008 – September 30, 2012
<b>FISCAL YEAR &amp; FUNDING LEVEL</b>	FY 2008: USD 4,900,000
<b>PROBLEM TO BE ADDRESSED</b>	Despite Brazil's great efforts to eliminate child labor during the past two decades, there are still 5.1 million children between 5 and 17 years of age who work and 10% of them are found in the State of Bahia. Bahia, the largest state in the Northeast region, has a population of 14 million who are mostly of African descendant. Bahia has high levels of poverty, illiteracy, and social exclusion. The State of Bahia, with the support of the federal government of Brazil, is committed to becoming the first Brazilian "child labor-free state" and setting an example that can be replicated across the country.
<b>TARGETS</b>	This project targets 7,000 children for withdrawal and 7,000 children for prevention from the worst forms of labor in the child domestic labor (CDL), informal urban labor, and the agricultural sectors. Project interventions will focus on the semi-arid Northeast II territory (State of Bahia,) that includes the following municipalities: Sitio do Quino, Jeremoabo, Fátima, Adustina, Ribeira do Amparo, Coronel João Sá, Pedro Alexandre, Santa Brígida, Paripiranga, Euclides da Cunha, Nova Soure, Banzaê, Novo Triunfo, Heliópolis, Cícero Dantas, Antas, Cipó, and Ribeira do Pombal.
<b>PROJECT OBJECTIVES</b>	Contribute to the elimination of the worst forms of child labor in Brazil, particularly in the State of Bahia, and provide support for Bahia's efforts to move toward a child labor-free state.  Intermediate objectives include: <ul style="list-style-type: none"><li>• Improve the knowledge base on the worst forms of child labor in Bahia.</li><li>• Change attitudes toward child labor in target areas, based on a planned communications strategy.</li><li>• Strengthen legal frameworks at federal and state levels.</li><li>• Increase capacity of national, state, and municipal public and private institutions, employers' and workers' organizations, and civil society organizations.</li></ul>

- Conduct research on child labor issues, including commercial sexual exploitation of children and adolescents (CSEC), and drug trafficking;
