## Financial and Activity Report (sheet 2 of 2)

### Major Completed Actions (Short bulleted list of the major actions taken to date.)

#### **Employment and Training Administration (ETA)**

As of October 9, \$2.6 billion has been distributed to a total of 32 states for Unemployment Insurance (UI) Modernization incentive payments. Applications from Massachusetts, Montana, Colorado, and Alaska are pending approval for their remaining 2/3 shares of the UI Modernization incentive payments.

Wyoming met the threshold for a high unemployment period in the Emergency Unemployment Compensation (EUC) program and will trigger “on” to the second tier of EUC benefits for weeks of unemployment beginning October 4, 2009.

ETA’s Office of Unemployment Insurance is monitoring South Carolina’s unemployment rates and anticipates that South Carolina will trigger “off” Extended Benefits in the week ending October 10, 2009.

On October 7, ETA released TEGL 3-09, Change 1, Information and Guidance on the Two New Work Opportunity Tax Credit (WOTC) Targeted Groups Introduced by the American Recovery and Reinvestment Act of 2009. The TEGL grants an extension period to all State Workforce Agencies and employers for the uninterrupted use of 2008 WOTC processing forms.

The U.S. Department of Labor approved a Recovery Act funded National Emergency Grant (NEG) of \$553,237 to serve approximately 100 of the 168 workers affected by the closure of the WestPoint Home manufacturing plant in Maine. All of the workers have been certified as eligible for Trade Adjustment Assistance (TAA). This project will provide these trade-certified dislocated workers with access to “wrap-around” and supportive services not covered under the TAA program.

ETA continues to see an increase in the number of trade petitions submitted since the 2009 Trade Adjustment Assistance (TAA) amendments mandated in the Recovery Act took effect on May 18, 2009. As of October 9, there have been 1,100 determinations made on cases filed under the new law.

#### **Employee Benefits Security Administration (EBSA)**

EBSA continues to respond to hundreds of COBRA inquiries on a daily basis. There have been almost 139,500 since the enactment of the ARRA.

EBSA now has over 42,000 subscribers to [www.dol.gov/cobra](http://www.dol.gov/cobra) who will receive automatic notices of new or updated COBRA announcements with over 1,760,000 total visitors since enactment of the ARRA.



**Major Planned Actions (Short bulleted list of the major planned actions)**

ETA published Solicitation for Grant Applications (SGA) for six Recovery Act-funded competitive grant programs during the summer. The Health Care Sector and Other High Growth and Emerging Industries SGA closed on October 5. The State Energy Sector Partnership and Training Grants SGA is still open for receipt of applications and will close on October 20.

ETA continues to finalize the release of several Recovery Act-related Advisories: TEGL No. 22-08, Change 1, on the Trade Adjustment Assistance Operating Instructions, including a series of Questions and Answers; TEGL on Trade Adjustment Assistance Funding Allocations for FY 2010 Training Funds using the Formula Enacted Under the Recovery Act 2009 Amendments; TEGL on the Use of Health Coverage Tax Credit Funds Made Available by the Recovery Act; TEN on Intent to Change Reporting Requirements for the Workforce Investment Act Standardized Record Data; and UIPL 14-09, Change 2, Special Transfers for Unemployment Compensation Modernization and Administration and Relief from Interest on Advances.
