ETA reports that 100% of Recovery Act grantees have reported financial and programmatic information to recovery.gov, as required by Section 1512 of the law.	ETA National and Regional Office designated staff have been working with ARRA grantees to help them meet Section 1512 recipient reporting requirements, and will be performing data quality reviews between October 22 and 29. Recipient reporting data will be published on October 30.
As of October 23, \$2.7 billion has been distributed to a total of 32 states for Unemployment Insurance (UI) Modernization incentive payments.	The Total Unemployment Rates for states will be released on October 21, and ETA staff will be analyzing their impact on triggering Extended Benefits and Emergency Unemployment Compensation.
Montana and Colorado were approved for their 2/3 (full) share of the UI Modernization incentive grants on October 14 and October 15, respectively.	ETA continues to finalize the release of several Recovery Act-related advisories: TEGL No. 22-08, Change 1, on the Trade Adjustment Assistance Operating Instructions, including a series of Questions and Answers; TEGL on the Use of Health Coverage Tax Credit Funds Made Available by the Recovery Act; TEN on Intent to Change Reporting Requirements for the Workforce Investment Act Standardized Record Data; and UIPL 14-09, Change 2, Special Transfers for Unemployment Compensation Modernization and Administration and Relief from Interest on Advances.
An application from Massachusetts for its remaining 2/3 share of the UI Modernization incentive payments is under review.	On October 22, ETA announced a \$3.3 million National Emergency Grant to assist approximately 600 workers affected by layoffs at nine companies in Massachusetts' information, manufacturing, retail and transportation industries. This grant will be funded by resources made available under the Recovery Act.
On October 20, the last of the green jobs, health care and high growth grant solicitations funded by the Recovery Act closed with significant response. The green jobs grants solicitation, approximately \$500 million, will prepare workers for careers in the energy efficiency and renewable energy sectors. About 900 applications which were fully responsive to the grant requirements were received. This response is significant, particularly because the solicitations largely required significant partnerships between labor and employers and \$150 million is targeted toward underserved communities. In addition to the green jobs grants, \$220 million will be made available for training in health care and other high growth sectors, such as advanced manufacturing and broadband. Over 750 applications for this solicitation were received. Of the total \$720 million available for these grants, approximately \$75 million is targeted toward auto communities.	On October 22, ETA announced two National Emergency Grants to the state of Oregon. A \$1.4 million grant will assist approximately 328 workers affected by layoffs from Cessna Aircraft Co. in Bend, Oregon. A \$3.85 million grant will assist about 1,430 workers affected by layoffs from Monaco Coach Corp. in Coburg and Hines, Oregon. These grants will be funded by resources made available under the Recovery Act.
ETA continues to see an increase in the number of trade petitions submitted since the 2009 Trade Adjustment Assistance (TAA) amendments mandated in the Recovery Act took effect on May 18, 2009. As of October 13, there have been nearly 1,300 determinations made on cases filed under the new law.	
<b>Employee Benefits Security Administration (EBSA)</b>	
EBSA continues to respond to hundreds of COBRA inquiries on a daily basis. There have been almost 144,000 since the enactment of the ARRA.	
EBSA now has over 43,000 subscribers to www.dol.gov/cobra who will receive automatic notices of new or updated COBRA announcements with over 1,810,000 total visitors since enactment of the ARRA.	
EBSA continues to receive applications for expedited review of COBRA premium subsidy denials bringing the cumulative total to 10,897.	
<b>Office of Recovery for Auto Communities and Workers</b>	
Dr. Ed Montgomery, the Executive Director of the White House Council on Auto Communities and Workers and Director of the Office of Recovery for Auto Communities and Workers, led the second meeting of the "Cities in Transition" working group on October 19. This is a group comprised of Dr. Montgomery's Office of Recovery for Auto Communities and Workers, the White House Office of Urban Affairs, and the NEC and the DPC's cross-agency policy development process focused on place-based initiatives. This group will focus on addressing the special needs of cities in transition, roughly defined as communities that will still be grappling with high unemployment and other issues when the recession ends, as a result of structural changes in their economies in recent years.	
On October 20, Dr. Ed Montgomery, the Executive Director of the White House Council on Auto Communities and Workers and Director of the Office of Recovery for Auto Communities and Workers, and his staff held calls with the staff of Senator Ben Nelson and local officials from Cozad, NE where a local auto supplier is poised to lay off 500 workers (in a town of 4000). The call included DC staff from several federal agencies who discussed resources that could be helpful to the community as they work to recover in both the short and long-term.	
On October 20, Dr. Montgomery and his staff also organized and participated in a call between Louisiana's Secretary for Economic Development, Steven Moret, and leadership from Motors Liquidation Company (Old GM) to talk about how the state can best pursue a deal to have China continue operations at the closed Hummer plant in Shreveport, following its deal with GM to purchase the brand. This is part of a broader effort to return closed auto facilities back to productive economic use as quickly as possible.
