<b>Employment and Training Administration (ETA)</b>	
As of October 30, 2009, \$2.7 billion has been distributed to a total of 32 states for Unemployment Insurance (UI) Modernization incentive payments. An application from Massachusetts for its remaining 2/3 share of the UI Modernization incentive payments is under review.	Data from the month of September 2009 on participation in Recovery Act-funded Workforce Investment Act programs will be available for publication on DOL's recovery website and Recovery.gov by November 2, 2009.
The Total Unemployment Rates (TURs) for states were released on October 21, 2009, and the following changes will occur for the Extended Benefits (EB) and Emergency Unemployment Compensation (EUC) programs: Though Minnesota has been in a High Unemployment Period, it was reported on October 21 that Minnesota's three-month seasonally adjusted TUR is below the 8.0% threshold, and Minnesota will therefore trigger "off" a High Unemployment Period in the EB program as of the week ending November 14, 2009; Texas and Connecticut have three-month seasonally adjusted TURs that meet or exceed the 8.0% threshold, and will subsequently trigger "on" to a High Unemployment Period in the EB program beginning November 8, 2009.	ETA UI and Regional Office staff are scheduled to participate in oversight reviews of the Emergency Unemployment Compensation and the Federal Additional Compensation programs in Puerto Rico, Maine, Maryland and North Carolina during the week of November 2, 2009.
Utah's three-month seasonally adjusted TUR meets the threshold to trigger "on" to the second tier of EUC, effective November 8, 2009.	ETA continues to finalize the release of several Recovery Act-related advisories: TEGL No. 22-08, Change 1, on the TAA Operating Instructions, including a series of Questions and Answers; TEGL on the Use of Health Coverage Tax Credit Funds Made Available by the Recovery Act; and TEN on Intent to Change Reporting Requirements for the Workforce Investment Act Standardized Record Data.
On October 27, 2009, the Department of Labor announced a \$6 million National Emergency Grant (NEG) funded by resources made available under the Recovery Act to provide an estimated 1,550 jobless workers in Kentucky with partial premium payments for health insurance coverage. The grant, awarded to the Kentucky Education and Workforce Development Cabinet, Department for Workforce Investment, will be used to make "gap filler" payments for unemployed individuals who are receiving TAA benefits and are eligible for the Health Coverage Tax Credit program.	
On October 27, 2009, the Department of Labor announced a \$372,839 National Emergency Grant (NEG) funded by resources made available under the Recovery Act to assist about 65 workers affected by layoffs at General Electric Security Inc., a wholly-owned subsidiary of General Electric Co. in Pittsfield, Maine. Awarded to the Maine Department of Labor, this grant will be operated by the Central/Western Maine Workforce Investment Board. The grant will provide affected workers with access to dislocated worker services.	
ETA National and Regional Office designated staff performed data quality reviews of Recovery Act grant recipient reports during October 22-29, 2009, per Recovery Act Section 1512 and Office of Management and Budget requirements. Recipient reporting data was published on October 30.	
ETA continues to see an increase in the number of trade petitions submitted since the 2009 Trade Adjustment Assistance (TAA) amendments mandated in the Recovery Act took effect on May 18, 2009. As of October 30, 2009, there have been 1,372 determinations made on cases filed under the new law.	
ETA's Division of Trade Adjustment Assistance has begun developing a grant solicitation for outreach assistance to stakeholders and the general public on the changes incurred as part of reauthorizing and amending the TAA program under the Recovery Act.	
<b>Employee Benefits Security Administration (EBSA)</b>	
EBSA continues to respond to hundreds of COBRA inquiries on a daily basis. There have been almost 146,500 since the enactment of the ARRA.	
EBSA now has over 43,500 subscribers to www.dol.gov/cobra who will receive automatic notices of new or updated COBRA announcements with over 1,840,000 total visitors since enactment of the ARRA.	
EBSA continues to receive applications for expedited review of COBRA premium subsidy denials bringing the cumulative total to 11,245.	
<b>Office of Recovery for Auto Communities and Workers</b>	
Dr. Ed Montgomery, the Executive Director of the White House Council on Auto Communities and Workers and Director of the Office of Recovery for Auto Communities and Workers, led the third meeting of the "Cities in Transition" working group on October 26. This is a group comprised of Dr. Montgomery's Office of Recovery for Auto Communities and Workers, the White House Office of Urban Affairs, and the NEC and the DPC's cross-agency policy development process focused on place-based initiatives. The working group will focus on addressing the special needs of cities in transition, roughly defined as communities that will still be grappling with high unemployment and other issues when the recession ends, as a result of structural changes in their economies in recent years.	
On October 27, Dr. Montgomery appeared in Wilmington, Delaware with Vice President Biden to announce Fisker's intention to use its DOE funding to purchase and produce electric cars at the former GM plant in Wilmington. It's estimated that 2000 jobs will be created at the site, with 3000 jobs in the supply chain.
