
The school attendance rate of children participating in work in 2018 also increased by nearly 20% compared to 2012








It is clear from these findings that increasing intensity of involvement in economic activities has a negative impact on children's involvement in education.




As economic activities intensify, the share of male engagement increases.




Working Child Hazardous Children Labour Child Labour

Rate of employment in the industry/construction sector rises as intensity of economic participation increases.



The rate of children working for over 40 hours per week rises alongside the intensity of economic engagement.

► Working Children


Working children include 5 to 17 year olds who participate in economic activities for at least 1 hour at any day in the reference week. Not all working children are in child labour.

Child Labour

Child labour is work that has been prohibited for children either because of their age or because of the nature of the tasks involved. If a child starts work at too young an age, works for too many hours, or undertakes work that impacts their physical or mental health, development or schooling, this constitutes child labour.














Boys are more likely to engage in child labour than girls

of children in child labour could not estimate their

average monthly income in the past 12 months.

However, the average income estimated (predominantly by 15-17 year olds) was around 2.5 million VND (US\$108) per month.



This is equivalent to three fourths of the average income of an adult employee.







Hazardous **Child Labour**

Hazardous child labour is work which jeopardises the health, safety or morals of a child. This includes work such as construction, mining, work involving dangerous chemicals, heavy machinery, alcohol or ilicit activities.
