Amendment 3:

CDOT original submitted a budget revision in Aug 2021 and requested to use all the residual funds for a Bustang software project under the the scope of ICB (634-00). However, after the revision was approved, we realized the proposed Bustang software project will have to go through a lengthy RFP process to procure the software. Given we want to close the grant as soon as possible, this solution is not ideal. Therefore, CDOT is requesting this amendment to change the project from software purchase to van purchase through current CDOT van price agreement.

This amendment will be adding a new ALI for van purchase under the ICB scope without any additional funds added.

  - b. Two ADA accessible 35 ft bus replacements with a useful life of 350,000 miles/ 7 years
  - c. Two ADA accessible cutaway bus replacements with a useful life of 150,000 miles/5 years
  - d. One ADA accessible van replacement with a useful life of 150,000 miles/ 5 years

CDOT has evaluated sub-recipient's applications and confirmed that all replaced vehicles have met their useful life. All sub-recipients are required to provide the local match. The local match sources were identified in the POP, please refer to the POP for details.

Projects in this rolling stock scope qualify as Class II(C)-Categorical Exclusions (C-List) Type 07: Acquisition, Maintenance of Vehicles/Equipment.

- 2) 113-00 Bus Stations/Stops at the total FTA amount of \$120,000 with a 80/20 match rate for Eagle County Avon Station Bus Shelter Replacement (North side of Benchmark Road). This facility construction project will use 2017 Section 5311 funds for a bus shelter replacement in Avon, Colorado, FTA Region 8. The useful life of this shelter is 15 years. Eagle County Transit (ECO Transit) will fund the local match with sales tax collections. The bus shelter will replace a temporary shelter at one of ECO Transit's busiest stops, Avon Station. This project is located near 75 Benchmark Road in Avon, about 50 feet away from the current shelter. The new shelter will be a permanent structure of metal and wood. The shelter will serve passengers using fixed route and ADA complementary transit buses of both ECO

Transit and Avon Transit. The Town of Avon owns the land, where the shelter will be located but has signed a 25 year lease agreement with ECO Transit for the location, operation, construction, maintenance, and repair of an access to and from the bus shelter. The bus shelter will use existing electrical lines to provide lighting for waiting passengers.

Avon bus shelter project qualifies as Class II(C)-Categorical Exclusions (C-List) Type 09: Assembly or Construction of Facility. Eagle County submitted Catex to FTA Region 8 for review on 7/11/2016.

The sub-recipient will comply with ADA standards for Transportation facilities when installing new bus shelter.

3) 114-00 Acquisition of Bus Support Equip for a service truck in the amount of \$24,946 (FTA) at an 80/20 match rate.

CDOT awarded Cripple Creek transit to purchase a service truck for the purpose of picking up transit parts, cleaning transit shelters and providing transportation for staff to training event and conference. City of Cripple Creek provided the 20% local match through the city general funds.

The service truck project qualifies as Class II(C)-Categorical Exclusions (C-List) Type 07: Acquisition, Maintenance of Vehicles/Equipment. The useful life of the truck is 150,000 miles/ 5 years.
