BGCAP provides three rural public intercity feeder routes to make meaningful connections to distant points. Danville Connection is available from Danville, KY to Lexington, KY. Frankfort Connection is available from Frankfort, KY to Lexington, KY. JessLex is available from Nicholasville, KY to Lexington, KY.

CASK will operate two intercity routes to make meaningful connections to distant points (such as Greyhound) in Bowling Green, KY. One route will begin in rural Barren County and go through rural Allen County before ending in Bowling Green, KY. The second route will begin in rural Butler County and will end in Warren County.

CKCAC provides intercity services to and from the Greyhound Bus Stations in Louisville, Lexington, and Sonora, KY as well as to the Lexington and Louisville airports so that passengers can make meaningful connections to distant points. Pickups occur in CKCAC's rural operating area (Lebanon, Bardstown, Hodgenville, Hardinsburg, and Leitchfield, KY).

FCTA provides intercity transportation to and from the Amtrak train station in Fulton, KY so that passengers can make meaningful connections to distant points. There are two trains that stop at the station each morning: one connecting to Chicago, IL and another to New Orleans, LA. FCTA will go to any residence in its operating area (Carlisle County, Fulton County, Graves County, and Hickman County, Kentucky) and pick up the general public and transport them to and from the station.

LWT provides intercity bus transportation from Bullitt County, Kentucky into the urbanized area of Louisville, KY to provide meaningful connections to distant points by connecting with the Greyhound Bus Station, the International Airport, and Transit Authority of River City (TARC).

PTA provides intercity bus service to and from the Greyhound Bus Terminal, Barkley Regional Airport, and Miller Trailways so that passengers can make meaningful connections to distant points. PTA's service area includes Ballard, Marshall, and McCracken Counties in rural Kentucky.

SVTS provides intercity services to and from Lexington and Ashland, KY to provide meaningful connections to distant points via the larger transportation network such as Greyhound and airports. SVTS provides this service for residents of Floyd, Johnson, Magoffin, Martin, and Pike Counties.
