

What it is...

An electronic document submission system that allows claimants (and potential claimants) to:

- Complete and electronically sign claim forms
- Complete Benefit Payment Forms
- Upload documents to an Existing Case
- Check the status of submitted documents

What it is (continued)...

One of 3 ways a claimant can use to submit forms and documents:

- 1. Using the U.S. Mail
 - Claimants have the option of mailing completed forms and documents to our Central Mail Room
- 2. Contacting/Visiting the nearest Resource Center
 - The Resource Centers have the ability to upload documents directly to the case file and/or the case create queue
- 3. Energy Document Portal
 - Using the Portal to submit digitally signed forms and documents to the case file and/or case create queue

What it is not...

A website that provides Claimants and Authorized Representatives access to view case information, such as recent actions, compensation information, and case file documents.

- For this access, Claimants and Authorized Representatives can register for access to the Employees' Compensation Operations & Management Portal (ECOMP)
 - Claimants deeoic.dol.gov
 - Authorized Representatives owcp.industrypartners.dol.gov

Background

The Energy Document Portal started in 2016 with the ability to upload documents in to a case file. Other functionality has been added over the last few years.

- In FY-22, there were <u>125,498</u> documents uploaded through the Portal's Upload document feature
- The ability to file and digitally sign claim forms began in July 2022.

 As of today, there have been 172 claims submitted through the Portal
 - The option to submit an Employment History with a claim form was added in December of 2022 As of today there have been 34 EE-3s submitted through the Portal
- The ability to digitally sign and submit the Benefit Payment Form started in October 2022 and as of today, there have been 737 submitted through the Portal
- The ability to digitally sign and submit Claim for Medical
 Reimbursement and Medical Travel Refund Request started in March
 2023. As of today there have been 115 submitted through the Portal
