Amendment #3 (February 2020) Funds being used are FY18 Intercity funds (Section 5311) in the amount of \$1,760,483. This funding will provide operational assistance. The Intercity Bus Projects included in this amendment meets the minimum 15% (\$1,760,483) of FY18 apportionment (\$11,736,556).

This funding is for the existing intercity routes with Village Tours, Greyhound Bus, and Jefferson Lines. These projects line up with our 2012 Statewide Intercity Bus Study recommendations. These requests are expected to utilize 5311(f) funds for operating expenses for services within the State of Kansas. KDOT is in the process of updating our Statewide Intercity Bus Study to identify any additional routes that would provide needed services.

KDOT SAM Expiration - 2-21-21

Amendment #2 (August 2019) Funds being used are FY17 Intercity funds (Section 5311) in the amount of \$1,697,118. This funding will provide operational assistance and will be used for the purchase of a 45" bus for Village Tours. The Intercity Bus Projects included in this amendment meets the minimum 15% (\$1,183,851) of FY17 apportionment (\$7,892,343).

Amendment #1 (June 2018) is for funding of Section 5311 INTERCITY BUS: The Intercity Bus Projects included in this amendment meets the minimum 15% (\$1,669,341) of FY16 apportionment (\$11,128,940).

This funding is for the existing intercity route between Wichita and Salina. In addition to continuing the current route, we are looking to expand the network to currently underserved areas of the state. Additional routes have been identified for Wichita to Joplin, Kansas City to Tulsa, and Kansas City to Salina. These projects line up with our 2012 Statewide Intercity Bus Study recommendations. These requests are expected to utilize 5311(f) funds for operating expenses for services within the State of Kansas. The portions outside the state will be funded by a separate funding source. The Kansas City to Tulsa route is an existing route, but would be new to our intercity network.

INTERCITY BUS: The Intercity Bus Projects meets the minimum 15% (\$1,642,584) of FY15 apportionment (\$10,948,814), of which \$358,678 (3%) was applied for in KS-2016-014-03 and this grant application includes \$1,283,906 of additional intercity bus projects.

This funding is for the existing intercity routes between Wichita and Salina, and Wichita to Pueblo. In addition to continuing the current routes on the intercity network (Pueblo and Salina connections from Wichita), we are looking to expand the network to currently underserved areas of the state. The current priority of expansion is in Southeast Kansas. We have realized an increased interest in our 5311(f) program from intercity providers and expect more requests for funding in the 2017 call for projects that will ideally line up with our 2012 Statewide Intercity Bus Study recommendations. These requests are expected to utilize 5311(f) funds for both operating and capital expenses.

<u>Application Executive Summary:</u> Amendment #3 (February 2020) Funds being used are FY18 Intercity funds (Section 5311) in the amount of \$1,760,483. This funding will provide operational assistance. The Intercity Bus Projects included in this amendment meets the minimum 15% (\$1,760,483) of FY18 apportionment (\$11,736,556).

This funding is for the existing intercity routes with Village Tours, Greyhound Bus, and Jefferson Lines. These projects line up with our 2012 Statewide Intercity Bus Study recommendations. These requests are

expected to utilize 5311(f) funds for operating expenses for services within the State of Kansas. KDOT is in the process of updating our Statewide Intercity Bus Study to identify any additional routes that would provide needed services.

KDOT SAM Expiration - 2-21-21

Amendment #2 (August 2019) Funds being used are FY17 Intercity funds (Section 5311) in the amount of \$1,697,118. This funding will provide operational assistance and will be used for the purchase of a 45" bus for Village Tours. The Intercity Bus Projects included in this amendment meets the minimum 15% (\$1,183,851) of FY17 apportionment (\$7,892,343).

Amendment #1 (June 2018) is for funding of Section 5311 INTERCITY BUS: The Intercity Bus Projects included in this amendment meets the minimum 15% (\$1,669,341) of FY16 apportionment (\$11,128,940).

This funding is for the existing intercity route between Wichita and Salina. In addition to continuing the current route, we are looking to expand the network to currently underserved areas of the state. Additional routes have been identified for Wichita to Joplin, Kansas City to Tulsa, and Kansas City to Salina. These projects line up with our 2012 Statewide Intercity Bus Study recommendations. These requests are expected to utilize 5311(f) funds for operating expenses for services within the State of Kansas. The portions outside the state will be funded by a separate funding source. The Kansas City to Tulsa route is an existing route, but would be new to our intercity network.

The current SAM expiration date is 03/07/19.

Original grant application is utilizing the remaining FY 15 Intercity Bus apportionment.

INTERCITY BUS: The Intercity Bus Projects meets the minimum 15% (\$1,642,584) of FY15 apportionment (\$10,948,814), of which \$358,678 (3%) was applied for in KS-2016-014-03 and this grant application includes \$1,283,906 of additional intercity bus projects.

This funding is for the existing intercity routes between Wichita and Salina, and Wichita to Pueblo. In addition to continuing the current routes on the intercity network (Pueblo and Salina connections from Wichita), we are looking to expand the network to currently underserved areas of the state. The current priority of expansion is in Southeast Kansas. We have realized an increased interest in our 5311(f) program from intercity providers and expect more requests for funding in the 2017 call for projects that will ideally line up with our 2012 Statewide Intercity Bus Study recommendations. These requests are expected to utilize 5311(f) funds for both operating and capital expenses.
