Reimburse currently contracted FTA Section 5311 sub recipients for allowable operating expenses generally eligible under those programs to prevent, prepare for, and respond to COVID-19. Further, the sub recipients are also eligible to include operating expenses to maintain transit services as well as paying for administrative leave for transit personnel due to reduced operations during an emergency.
