Application Executive Summary

To provide funding for rural transit districts to replace 233 vehicles that exceeded their useful life benchmark and to maintain a state of good repair (SGR); to rehabilitate one existing maintenance facility and advance six facilities to construction readiness. For fleet projects, 36 subrecipients are identified in the attached POP, all of the federal funds in the budget are matched by TDC (NEED TOTAL) approved by the attached TxDOT letter. For facility projects, seven subrecipients are identified in the attached pop, and all of the federal funds in the budget are matched by state or TDC.

Starting in 2015 with the receipt of USDOT TIGER program funding, TxDOT has proceeded to plan, design, and construct 9 facilities. This proposal brings that total to 10, and sets in motion key project development tasks leading up to the construction phase for 6 more. The Department anticipates future discretionary program applications for construction of these 6 projects following completion of remaining tasks funded with this project application. Ultimately, TxDOT anticipates completing construction of these projects with a combination of discretionary and receipt of annual program apportionments.

The facility projects are summarized as follows:

Facility Rehab:

Brazos Transit District Livingston: This is a facility rehab to replace/upgrade certain parts of the building that are in poor condition; the project will be funded with \$300,00 of flex funds and matched with TDC

Construction Readiness:

REAL: A multi-modal transit facility. To bring this project to a state of construction readiness, the project will cost \$680,107; \$544,086 will be 5339 Discretionary and \$136,021 will be state funded.

Rolling Plains Management Corporation: RPMC is seeking to bring their Adminstrative and Operations center to a state of construction readiness. To meet this task, the total cost is \$275,723; \$220,578 will be 5339 Discretionary funds and \$55,145 will be state funds.

Concho Valley Transit District: To elevate their proposed new bus maintenance facility to a state of construction readiness. To fund the steps prior to construction readiness will cost \$450,000. The project will be funded with \$291,521 of 5339 Discretionary funds, \$85,598 of Flex funds, and \$72,881 of state funds; the

remaining match requirement will be met using TDC.

Panhandle Community Services: A new maintenance facility that includes land acquisition costs. To bring this proposal to a state of construction readiness, the cost will be \$1,825,000. The project will be funded with \$1,460,000 of 5339 Discretionary and \$365,000 of state dollars.

El Paso County: 15 new bus passenger shelters. The cost to elevate this project to a state of construction readiness is \$224,000; \$179,2000 will derive from 5339 Discretionary and \$44,800 from state funds. STAR Transit: To bring their bus transfer center to a state of construction readiness, the cost will be \$228,061. \$182,449 will originate from 5339 Discretionary funds and \$45,612 from state funds.
