Application Executive Summary

West Virginia Department of Transportation, Division of Public Transit (WVDOT) is applying FFYs 2018 and 2019 Section 5311 Nonurbanized Area Formula Program funds and the Section 5311(b)(3) Rural Transit Assistance Program (RTAP) in the total amount of \$21,186,538 to support the state's Section 5311 Program of Projects (POP).

The projects include operating assistance for eleven (11) Rural Operators (\$10,542,807 Federal) and two (2) Intercity Bus Operators (\$2,557,205 Federal); capital assistance (\$2,243,220 Federal) for ten (10) Rural Operators; training and technical assistance services (\$354,502 Federal) funded under the Rural Transit Assistance Program (RTAP); and, state administration (\$1,704,804 Federal). The total number of recipients funded in the POP include: thirteen (13) subrecipients that are eleven (11) rural operators and two (2) intercity bus operators.
