Extended Budget Description

Amendment #2 - NCDOT is applying for \$4,339,816 from Section FFY2019 5311 Urbanized Formula Grant Program for the FY21 Intercity projects. NCDOT will spend more than \$15% for Intercity projects totaling \$12,265,682 for the FFY21-FFY22. We are applying for \$4,339,816 of those funds to meet the intercity needs. The remaining \$1,793,025 will come from unspent Intercity funds from grant NC-2017-052-01 that was awarded in SFY 2019.

Funding will be used in support of Intercity bus services which will be provided by Greyhound and Sunway Charters dba Trolley's Inc. Greyhound will provide services for (6) underserved rural routes once daily in each direction from Raleigh to Norfolk VA along US 64 and US 258 with stops at Raleigh, Rocky Mount, Tarboro, Ahoskie and Norfolk Va.; from Raleigh to Wilmington along US 70, US 117 and 1-40 with stops at Raleigh, Smithfield, Goldsboro, Wallace and Wilmington; from Raleigh to Jacksonville, via US 264, 1-795, US 70 and US 258 with stops at Raleigh, Wilson, Goldsboro, Kinston and Jacksonville, from Raleigh to Jacksonville, via Greenville along US 64, US 264 and US 17 with stops in Rocky Mount, Wilson, Greenville, Washington and New Bern, from Norfolk, VA to Myrtle Beach, SC via Greenville along US 17, US 64 US 13, US 264 and US 17 with stops in Elizabeth City, Edenton, Greenville, Washington, New Bern, Jacksonville and Wilmington and from Charlotte to Wilmington through Fayetteville with stops at Monroe, Wadesboro, Rockingham, Laurinburg, Fayetteville, Lumberton and Whiteville.

Sunway Charters dba Trolley's Inc will service two underserved rural routes from Greensboro to Boone and from Charlotte To Boone both directions operating twice daily.

The intercity Bus grant is a 2-year award for FY21 and FY22. Local match is an in-kind match provided by Greyhound Lines, Inc. NCDOT will use previous funds from an older FTA grant to fund the remainder of the project.

The City of Wilson will purchase (2) 35' HD Low Floor Transit Buses to replace those that have met useful life. Subrecipient will follow useful life standards as defined in the 2016 State Management Plan. Useful life for these vehicles is 12 years or 500,000 miles.
