The Pennsylvania Department of Transportation (PennDOT) is applying for the balance of FFY 2019 and a partial amount of FFY 2020 Section 5311 Nonurbanized Area Formula Program funds, and the Section 5311 FFY 20 (b)(3) Rural Transit Assistance Program Funds (RTAP) in the total amount of \$27,456,263 (\$4,788,000 FFY 2019 Appalachian and \$22,236,469 FFY 2020 Nonurbanized Area Formula Program funds and \$431,794 FFY 2020 RTAP funds) to support the state's Section 5311 Program of Projects (POP). Please note that we're not applying for the FFY 2020 Appalachian funds as part of this application.
