Purpose: The purpose of this award is to provide the Maryland Transit Administration (MTA) and its subrecipients operating assistance, eligible capital projects, and for the rural transit assistance program (RTAP) to assist MTA and its subrecipients.

Activities to be Performed: Funds will be used to cover eligible operating expenses such as driver salaries, fuel, items having a useful life of less than one year, preventive maintenance, etc. in order to continue transit operations. Funds will also be used to cover eligible capital expenses such as the continued transit facility construction in Ocean City. Funds will also be used for the purchase of computer software, radios, cameras, and other equipment. Additionally, funds will be used for the purchase of replacement buses.

Expected Outcomes: Continued safe and effective operation of transit services for rural areas of Maryland.

Intended Beneficiaries: Maryland State transit agencies and citizens in the rural and non-urbanized areas of the state.

Subrecipient Activities: The following sixteen (16) subrecipients as providers of rural transit service: Allegany County, Baltimore County, Calvert County, Carroll County, Cecil County, Charles County, Dorchester County, Frederick County, Garrett County, Montgomery County, Ocean City, Prince George's County, Queen Anne's County, St. Mary's County, Talbot County, and Tri-County Council Lower Eastern Shore will receive operating assistance.
