Application Executive Summary

This is the State of Mississippi statewide application for funding the Section 5311 Rural Area Program for the period 10/1/2021 thru 12/31/2022. This application includes a total for \$29,253,023 in federal funds - (\$16,506,674 which is 100% the FFY 2020 Section 5311 Program apportionment and \$11,685,357 which is 71% of FFY 2021 Section 5311 Program apportionment. This application also includes Section 5311 (b) (3) RTAP funds of \$276,496 FFY 2020 and \$276,496 FFY 2021; Appalachian Development PT Assistance Program funds for FFY 2020 \$254,000 and funds for FFY 2021-\$254,000.)

Based on the allocations, the grant application will comprise of four (4) projects:

- 1. Rural Area allocation \$24,893,961
- 2. Appalachian allocation \$508,000
- 3. RTAP allocation \$552,992
- 4. State Administration \$3,298,070

This application programs the funds as follows: \$23,672,114 for sub-recipients routine non-operating and operating expenses; \$1,729,847 Intercity Bus requirements; RTAP of \$552,992, and State Administration of \$3,298,070. The required 15% of Intercity Bus funds is not programmed for Intercity Bus project. Only 5% is programmed for Intercity Bus project. The remaining 10% is allocated to Section 5311 sub-

recipients. We have attached the Governor's letter stating that the Intercity Bus needs have been met. Consultation meetings were held with intercity bus providers on April 20, 2020.

The total funds programmed in this application are \$44,195,122 with Federal funds totaling \$29,253,023. Local match (\$14,942,099) will come from each sub-recipient listed on the attached Program of Projects.

MDOT is the Designated/Direct Recipient of Section 5311 sub-recipients and of the funds apportioned. Additional Information

Continuing control over real property is a part of the sub-recipients' contractual agreement with MDOT. The language is as follows:

"When real property is acquired and/or developed under the terms of this Contract Agreement, CONTRACTOR grants to the DEPARTMENT a security interest in the real property to secure CONTRACTOR'S performance of the terms of this Contract Agreement and shall perfect that security interest by executing a deed of trust in a form acceptable to the DEPARTMENT and by filing that deed of trust in the land records of the county where the real property is located. At least ten days prior to the transfer of funds under the terms of this Contract Agreement for the acquisition and/or development of real property, the CONTRACTOR shall provide to the DEPARTMENT a title certificate from a licensed attorney to be selected by the DEPARTMENT showing that there are no encumbrances on the real property to be acquired and/or developed, and the CONTRACTOR shall have the title certificate updated immediately prior to the transfer of funds for the acquisition and/or development of the subject property." Consultation meetings were held with intercity bus providers on April 20, 2020. The Intercity Bus Provider receiving FTA funds from MDOT is Delta Bus Lines, Inc. Delta Bus Lines has been in operations for over 30 years, based in Clarksdale, MS. Intercity Bus routes runs from Memphis, TN to Baton Rouge, LA. The service averages over 600,000 miles per year.
