# **Application Executive Summary**

#### Amendment:

This amendment adds FFY2019, 2020 and 2021 Section 5311 Tribal Formula funds in the amounts of \$363,557, \$421,648 and \$385,232 respectively (all full apportionments). The total amount added in this Amendment is \$1,170,437 into the construction and oversight activity line items, and additional details have been added to these activities. Additionally, funds were added into the existing Design ALI to cover the actual amount of funds expended in design. The Federal share is 100%.

The Admin and Maintenance Facility will be funded using four grants:

Following completion of NEPA and final design this grant was amended to add funds and increase the level of detail provided in the grant. This Amendment does the following:

This amendment updated the total amount of design to the actual amount expended of \$247,818.

# Original:

This activity includes the conceptual design and NEPA evaluation and clearances. Once NEPA has been approved, final design and cost estimates will be developed for the construction of the administrative and maintenance facility on LBST land.

The administrative and maintenance facility will have the following elements:

- Administrative offices for 4 office staff, a dispatching center, kitchen/break room, bathrooms and locker rooms
- Customer waiting area
- Vehicle storage garage for up to 10 vehicles for future expansion needs
- Maintenance area, including office space, work shop area, storage space, 1 vehicle lift
- Bus wash
- Public and employee parking lot (20-25 spaces)
- Generator
- Perimeter security fencing
- Stormwater detention pond to deal with run off

A high level cost estimate was developed to estimate the cost of design based on other similar transit facilities built by nearby tribal transit providers. These other transit facilities averaged \$190 per square foot. Based on estimated space needs (approximately 10,000 square feet), LBST staff estimate that our facility will cost \$1.9M. We estimate that design will cost 10% of that, so this ALI uses \$190,000 for the conceptual design, NEPA work and final design.

An on-call contract for design services was put out for competitive selection in July 2020 and a selection was made in August 2020 and contracting process is in progress as of late August 2020. We expect to have a contract by the end of September 2020 and will initiate design shortly after.

# **Extended Budget Description**

#### Amendment:

This amendment uses remaining FFY2018 and full FFY2019 and FFY2020 and partial FFY2021 funds (add \$992,619 for a total in this ALI of \$1,159,974). This will fund the construction of a 120' by 80' building to house transit administration, customer waiting area, light maintenance and vehicle storage on tribal owned property. The project is located along the north side of Indian Affairs (BIA) Highway 10 in Lower Brule, South Dakota, approximately 1,200 feet west of the intersection of BIA 10 and BIA 5. A project location map can be found in the supplemental information.

Construction activities will include: excavation, backfill, grading, surfacing, asphalt approaches, installation of a power slide gate, chain link fence, and sewer/water service extension to accommodate the construction of a 120 foot by 80 foot perimeter building. The building will have on-site parking on the east side including an handicap accessible parking stall. Specific elements to be included:

- Administrative offices for 4 office staff, a dispatching center, kitchen/break room, bathrooms and locker rooms
- Customer waiting area
- Vehicle storage garage for up to 10 vehicles for future expansion needs
- Maintenance area, including office space, work shop area, storage space, 1 vehicle lift
- Bus wash
- Public and employee parking lot (20-25 spaces)
- Generator
- Perimeter security fencing
- Stormwater detention pond to deal with run off

An RFP for construction was released in June 2021 and award is anticipated in August 2021.

Federal share is 100%. The useful life of the structure is 40 years, the parking lot's useful life is 20 years and fittings and equipment's useful life is 10 years. Any equipment over \$5,000 will be reported out at grant closeout.

The recipient shall complete a Title VI equity analysis during the planning stage with regard to where a project is located or sited to ensure the location is selected without regard to race, color, or national origin. Recipients shall engage in outreach to persons potentially impacted by the siting of facilities. The Title VI equity analysis must compare the equity impacts of various siting alternatives, and the analysis must occur before the selection of the preferred site.
- b. When evaluating locations of facilities, recipients should give attention to other facilities with similar impacts in the area to determine if any cumulative adverse impacts might result. Analysis should be done at the Census tract or block group where appropriate to ensure that proper perspective is given to localized impacts.
- c. If the recipient determines that the location of the project will result in a disparate impact on the basis of race, color, or national origin, the recipient may only locate the project in that location if there is a substantial legitimate justification for locating the project there, and where there are no alternative locations that would have a less disparate impact on the basis of race, color, or national origin. The recipient must show how both tests are met; it is important to understand that in order to make this showing,

The total amount added in this Amendment is \$1,170,437 into the construction and oversight activity line items, and additional details have been added to these activities.
