Application Executive Summary

Amendment #1

The Vermont Agency of Transportation is requesting an additional \$210,000, in total, of 5311 funds. \$185,000 of the funds were apportioned to Vermont in FY2020 and \$25,000 were apportioned to New Hampshire in 2019, which were transferred to Vermont by NHDOT, to support Southeast Vermont Transit (SEVT) operating. The activities in this amendment are as following:

- \$185,000 of FY20 5311 funds will be added to the Intercity ALI to fund VTrans subrecipient Vermont Translines operating expenses.
- \$25,000 of FY19 5311 funds will be added to the Operating ALI to fund VTrans subrecipient SEVT's operating expenses.

VTrans is also completing the following budget revision through this amendment:

* The Operating Assistance ALI is being decreased by \$25,000 (FY18 5311 funds apportioned to SEVT for operating) and being moved to the Intercity ALI for Vermont Translines operating expenses (Transfer letter attached).

Overall, this amendment increases the Intercity Operating ALI by \$210,000. The total budget for the Operating ALI is unchanged. Both activities are reflected in the attached and revised Program of Projects. These funds will allow continued support for all existing transit projects in the rural areas in the state.

VTrans executed the FY21 Certifications and Assurances in TrAMS on January 27, 2021. All activities are programmed in the FY21 element of the current VT STIP. VTrans is current with all Civil Rights Requirements and FTA annual certifications. All administrative and statutory requirements have been met in accordance with the §5311Formula Funding, as articulated in FTA Circular 9040.1G. AMENDMENT 1- This amendment acts as a budget revision decreasing the Operating Assistance ALI by \$25,000 and increasing the Intercity ALI by \$25,000. Additionally, this amendment adds \$185,000 of FY2020 VTrans 5311 funds to the Intercity ALI. It also adds \$25,000 of New Hampshire 2019 5311 funds to the Operating Assistance ALI. These funds were transferred by NHDOT to support SEVT operating. The transfer letter is attached. Overall, the total budget for the Operating ALI is unchanged, and the budget for the Intercity Operating is increased by \$210,000.

ORIGINAL- Purpose - to provide statewide transit operations through the following competitively selected sub-recipients and private intercity providers. There are no construction funds in this application: See attached Program of Projects, POP, and the extended Budget Descriptions. This funding, \$4,634,614 is for SFY20, 21 and 22. This project primarily provides operating assistance to all Vermont sub-recipients, see attached description of providers. These providers cover the entire state of Vermont (see attached map of providers coverage area). This project comprises the whole of the application.

Project Benefits

These funds will allow continued support for all existing transit projects in the rural areas in the state. All except the urban sections of Chittenden County (small urban) are considered rural. See the VTrans website, http://publictransit.vermont.gov/providers#buses for detailed descriptions of statewide services. These services are comprised of fixed route, demand response by bus and volunteers, and ADA paratransit. Rural Transit Providers deliver over half of the rides (in a total of 5,000,000) in Vermont, an admirable accomplishment given the low-density nature of the state's rural areas. Vermont pays particular attention to basic mobility for all often focusing on the elderly, low income, disabled and those seeking to improve their housing and financial sustainability. VTrans invests in extensive commuter service to major employment centers and supports Intercity connectivity to the national bus system.
