Project Description

Southern Ute Tribe will use FY21 ARP Section 5311 Tribal competitive funding to procure a replacement vehicle to be used for an expansion in service to provide Dial a Ride (DAR) throughout the Southern Ute Indian Tribe Reservation in Ignacio, CO and the nearby town of Bayfield, CO (both in La Plata County). The Federal share is 100%.

Project Benefits

This project will allow the recipient to serve an increasing ridership and to continue the DAR service. The service has been successful at increasing the mobility of persons residing in the service area since it began service in 2012. It is currently the largest trip generator in the entire Road Runner Transit system. The service is open to the general public and approximately 80% of ridership is Native American.

Additional Information

Service hours are: Monday through Fridays from 12 p.m. to 6 p.m. and on Saturdays from 12 p.m. to 8 p.m. Expansion of services into Bayfield only began in April of 2021, and helps provide transportation options for riders attending the community college, and destinations to all Tribal government offices, Tribal enterprise and employment centers, public amenities such as the post office, grocery store, public schools and community centers.

Location Description

This vehicle will be used on the Ignacio Area Dial-a-Ride service, covering the Southern Ute Tribal Campus on the Southern Ute Indian Reservation, nearby housing projects and subdivision on tribal land, the Town of Ignacio, and an area three miles from the Town boundaries, and also into the city of Bayfield, approximately 10 miles north of Ignacio. The community is located in the Four Corners Area of Southwest Colorado, about 24 miles from Durango, bordering on the Colorado-New Mexico state line.
