Application Executive Summary

AMENDMENT 01:

During the reservation process for Award No. MT-2021-025-00 an incorrect fund source was obligated; Statewide ARP funds were obligated instead of Tribal ARP funds. This amendment is the first of two amendments required to correct the funding error.

Amendment 01 will add the full FFY 2021 apportionment of \$163,031 Section 5311 ARP Tribal formula funds to two new projects, identical to the original scope, as follows:

P4: Operating - *corrected* - for \$21,813; ACC: 2021.32.18.PF.1; FPC: 09

P5: Capital - *corrected* - for \$141,218; ACC: 2021.32.18.PF.1; FPC: 09

A second amendment will be processed to deobligate the incorrect fund source, FFY2021 Section 5311 ARP Statewide formula funds, in the amount of \$163,031 from Projects P1 and P2, ACC: 2021.32.18.PR.1.
