This application is to request FFY 2014 Section CMAQ funds apportioned to the State of California in the amount of \$1,511,830. These FHWA funds have been transferred to FTA for administration under Section 5311 guidance. The total funds requested in this application is \$1,511,830, which includes \$123, 148 in Transportation Development Credits..

Purpose:

The purpose of the award is to provide 2 replacement transit vehicles (Morongo Basin Transit Authority (MBTA)) and 2 service expansion vehicles (Mountain Area Regional Transit Authority (MARTA)).

Activities to be performed:

Funds will cover the cost of the new vehicles.
