Amendment 1

CDOT original submitted a budget revision in Aug 2021 and requested to use the residual funds for a Bustang software project under the the scope of ICB (634-00). However, after the revision was approved, we realized the proposed Bustang software project will have to go through a lengthy RFP process to procure the software. Given we want to close the grant as soon as possible, this solution is not ideal. Therefore, CDOT is requesting this amendment to move the funds from the software purchase to the van purchases.

The original amendment was requested in Sept 2021 but unfortunately not carried through due to a TrAMS system issue. Hence this amendment in April 2022.

This amendment will be adding a new ALI for the purchase of 6 vans under the ICB scope for Bustang Pegasus program.

Funds will be moved:

1) from the regular operating assistance scope (the residual funds in the amount of \$272,199) to the ICB scope for van purchases;

2) From a software purchase (\$71,483) to the van purchases under the same ICB scope;

Purpose: The purpose of this amendment is to continue using residual funds for Colorado Intercity Bus service through Bustang operation and provide ICB capital funds for 6 vans purchase.

Activities to be Performed: The scope of work includes purchasing rolling stock for ICB. The overall performance period for this amendment is March 1, 2022 through December 31, 2023.

Expected Outcomes: Funding will provide financial assistance for CDOT to purchase 6 vans for Bustang Pegasus program.

Intended Beneficiaries: CDOT Bustang Pegasus program which provides public transportation shuttle service on the Colorado I-70 mountain corridor.

Subrecipient Activities: No subrecipients will be involved as the funds will be utilized by CDOT Bustang Pegasus program.

Most of projects in this grant were closed and returned some FTA funds as cost saving. CDOT is requesting this budget revision to :1) transfer the cost saving of \$10,689 (FTA amount) from capital scope and \$198,716 from Project Admin scope to the Operating Scope in order to utilize all the cost savings for a 2021 RFTA Operating project; 2) The 5311(f) Trillium GTFS/AVL project was withdrawn and funded

through a FASTER grant, so CDOT is replacing this project with a similar software project-Bustang Family Vehicle & Facility maintenance software project; 3) extend the period of performance end date to 12/31/2023.

CDOT original submitted a budget revision in Aug 2021 and requested to use the residual funds for a Bustang software project under the the scope of ICB (634-00). However, after the revision was approved, we realized the proposed Bustang software project will have to go through a lengthy RFP process to procure the software. Given we want to close the grant as soon as possible, this solution is not ideal. Therefore, CDOT is requesting this amendment to move the funds from the software purchase to the van purchases.

The original amendment was requested in Sept 2021 but unfortunately not carried through due to a TrAMS system issue. Hence this amendment in April 2022.

This amendment will be adding a new ALI for the purchase of 6 vans under the ICB scope for Bustang Pegasus program.

Funds will be moved:

1) from the regular operating assistance scope (the residual funds in the amount of \$272,199) to the ICB scope for van purchases;

2) From a software purchase (\$71,483) to the van purchases under the same ICB scope;

Purpose: The purpose of this amendment is to continue using residual funds for Colorado Intercity Bus service through Bustang operation and provide ICB capital funds for 6 vans purchase.

Activities to be Performed: The scope of work includes purchasing rolling stock for ICB. The overall performance period for this amendment is March 1, 2022 through December 31, 2023.

Expected Outcomes: Funding will provide financial assistance for CDOT to purchase 6 vans for Bustang Pegasus program.

Intended Beneficiaries: CDOT Bustang Pegasus program which provides public transportation shuttle service on the Colorado I-70 mountain corridor.

Subrecipient Activities: No subrecipients will be involved as the funds will be utilized by CDOT Bustang Pegasus program.

Most of projects in this grant were closed and returned some FTA funds as cost saving. CDOT is requesting this budget revision to :1) transfer the cost saving of \$10,689 (FTA amount) from capital scope and \$198,716 from Project Admin scope to the Operating Scope in order to utilize all the cost savings for a 2021 RFTA Operating project; 2) The 5311(f) Trillium GTFS/AVL project was withdrawn and funded through a FASTER grant, so CDOT is replacing this project with a similar software project-Bustang Family Vehicle & Facility maintenance software project; 3) extend the period of performance end date to 12/31/2023.
