Amendment 01 - 3-4-2022

FY2020 FUNDS

Purpose: The purpose of this award is to provide the state of Oklahoma and its subrecipients operating assistance, eligible capital projects and for it's subrecipients.

Activities to be Performed: Funds will be used to cover eligible operating expenses such as driver salaries, fuel, items having a useful life of less than one year, and preventive maintenance, in order to continue transit operations. Funds will also be used to cover eligible capital expenses such as the purchase. Funds will also be used for training, technical assistance, and state administration.

Expected Outcomes: Continued safe and effective operation of transit services for rural areas of Oklahoma.

Intended Beneficiaries: Oklahoma State transit agencies and citizens in the rural and non-urbanized areas of the state.

Subrecipient Activities: 20 rural agencies will receive operating assistance, along with Six intercity bus operator. 1 IC agency (Greyhound) will receive capital funding for the purchase of a bus. This will be Pre-Award Authority because the subrecipients will be allowed to submit reimbursement for expenditures from October 1, 2020 to present after the award gets executed and ODOT executes an agreement with the subrecipients.

This Amendment is to add \$2,572,211 previously unobligated funds for intercity and operating \$435,341. The total amount of funds being obligated \$3,007,552 is as follows:
