The Salt River Pima-Maricopa Indian Community (SRPMIC) will utilize \$196,867 in lapsing FTA Tribal Transit Program (TTP) formula funds for operating expenses to support the existing tribal transit service. SRPMIC will also purchase a new replacement van to replace a van - vehicle #20-0237 VIN #1FBZX2CM4FKA63469, a frontline 2015 Ford Transit van with a current mileage of 147,968 - that will have reached the end of its useful life cycle. The van will be a 2024 gasoline powered Transit Works - 8 passenger van equipped with a wheelchair lift. #### **Project Benefits**

The transit system originates in SRPMIC and provides service to the neighboring communities of Scottsdale, Mesa and Tempe. The SRPMIC transit operation consists of ten (10) vehicles, 12 employees.
