Application Executive Summary

FY 2021 Mescalero Apache Tribe -Tribal Transit Discretionary Grant D2022-TRTR-024. The total Discretionary Grant award is \$276,421, for Passenger Shelters and support maintenance vehicle. The eligible Federal share for this grant is 100%, there is no local match required.

Purpose: The Mescalero Apache Tribe applied and was awarded this Discretionary grant for support maintenance vehicles and Bus Stop Shelters. The support maintenance vehicles include a Kubota M6-141DTC-F Tractor Mower and Laymor Sweeper, to mow and sweep the rights of way of roads. Ten (10) Tolar Passenger Bus Stop Shelters, to protect tribal members while waiting for the bus.

Activities to be performed: The Tribe will purchase a new mower and sweeper. We will purchase 10 new passenger bus stop Shelters.

Expected Outcomes: The Mower and Sweeper will be purchased and used to allow safer access for Tribal members at bus stop sites and will increase traffic visibility on the roadways. Dilapidated shelters that were given to the Tribe years ago need to be replaced. They are located on the right of ways, the new shelters will replace the old ones. Some stops do not even have a shelter. Because of the harsh climate elements, rain, snow, and heat, in rural New Mexico mountains, the shelters will make it bearable for tribal members to wait safely and comfortably for the next bus. This grant will allow the purchase of the new bus stop shelters to replace the old ones. The Mescalero Apache Tribe Roads Department will take care of the removal of the old shelters and the installation of the new shelters.

Intended Beneficiaries: The beneficiaries of the grant will be the Mescalero Apache Tribal members. By having new bus stop shelters, tribal members can wait safely and comfortably for the next bus. The rights of way will be mowed and groomed so that the Tribal members are safe from snakes and other wild animals. Tribal members don't have to worry about the bus or other on-coming traffic not seeing them as they walk on the shoulder and wait for the bus.

Subrecipient Activties: The Mescalero Apache Tribe is the Direct recipient, there are no sub recipients.

Project Description

The eligible Federal Share for this Discretionary Competitive Grant is 100%, ther is no local match required.

In rural New Mexico where the Mescalero Apache Tribe (MAT) Reservation lies, the terrain is a mountainous area. Tribal residents have to walk on the roadside to get to the bus stops. On the shoulders the grass and weeds are high and a place where snakes and other wild animals are found. The Mower will be used to keep the shoulders mowed and the Sweeper will groom the cut grass/weeds, at a level that can be safely walked on by Tribal members.

The tribe will purchase 10 new bus shelters to replace the old dilapidated shelters that were donated to the tribe many years ago. The current shelters are located on the right of ways, the new shelters will replace the old ones. The MAT roads department will install the shleters at the tribes expense.

Project Benefits

This is a safety issue for tribal residents, the benefit is to keep them safe from highway traffic by not having to walk on the roadway. Also, by not having to walk in the high grassy/weeded area, keeping them safe from snakes and other wild animals. Keeping the shoulders mowed and swept will allow tribal members to walk to the bus stop safely on the shoulder, instead of having to use the roadways. This will improve the visual acuity allowing members to see where they are walking.

By purchasing new Shelters, we will be able to replace the old dilapidated ones. This will benefit the tribal members directly and will address the state of good repair needs. It will also ensure climate protection for the Mescalero tribal members. The MAT is in a rural area and the time between stops are one and a half

hours. This makes for a long wait for our members. Our riders include everyone from the very young to our elders. They need a place to be able to sit safely while waiting for the bus.

Additional Information

The Mescalero Apache Tribe (MAT) is located in rural South Central New Mexico, in the Sacramento mountains within the Lincoln National Forest. A major highway (HWY70) runs directly through the Reservation. So the traffic level is very high.

Location Description

The Mescalero Apache Tribe is located in a very rural mountainous area in South Central New Mexico. It is located in the Sacramento Mountains, within the Lincoln National Forest. The climate is generally harsh, with steep temperature drops between day and night, high winds, run off from melting snow and rain. Climate change, places considerable stress on the mountain enviornment and the tribal members who live there.

Extended Budget Description

Please note that the eligible Federal share for this Discretionary Competitive grant is 100%, no local match is required. In addition, the Passenger Bus Shelters will be placed in the public right of way.

The Mescalero Apache Tribe (MAT) has 16 bus stops within the Reservation. Years ago, Santa Fe Trails, a system up in Santa Fe, NM, donated ten of their shelters that they were disposing of to the MAT. The tribe put the shelters up in various stops on the Reservation. There are still six stops with no shelters. All existing shelters are in very bad condition and need replacing. The MAT Road Department will remove the old shelters and install the new ones at the tribes expense. The Roads Supervisor will determine which stops will be replaced. Annually, the tribal representative (the Roads Supervisor) coordinates and meets with the Ztrans Director to go over the bus stops to determine if any need to be changed or moved. Ztrans is the Public Transportation provider for Otero and Lincoln counties. The MAT pays a subsidy to Ztrans for public transportation services. The current shelters are located on the right of ways, the new shelters will replace the old ones. The MAT roads department will install the shleters at the tribes expense.

This project will allow the Mescalero Apache Tribe to purchase a tractor and sweeper in order to mow and groom the rights of way for access to the bus stops for tribal members. The Tribe intends to purchase a Kabota M6-141 DTC-F Mower and LamorSM450-ST Sweeper. Updated bids and quotes will be obtained according to procurement procedures. This is currently an ongoing safety issue, with the weeds and grass being overgrown, and snakes and other wild animals are a threat to the Tribal members who have no choice except to walk in the roadway or the tall weeds, creating a safety hazard to vehicles and themselves while attempting to access the bus stops.

As required under DOT ADA Standard 810.2, the Tribe must ensure Bus stops must also connect via an accessible route to streets, sidewalks, or pedestrian paths. • As required under DOT ADA Standard 810.2, the Tribe must ensure the slope of the bus boarding and alighting area in the direction parallel to the roadway must be the same as that of the roadway to the maximum extent practicable. Perpendicular to the roadway, the slope must not exceed 1:48, that is, not more than 1 inch of rise over a horizontal distance of 48 inches.

• As required under DOT ADA Standard 810.3, the Tribe must ensure that the minimum

clear floor or ground space (as set forth in Section 305) must be entirely within the shelter to accommodate individuals using wheelchairs and must be connected to an accessible route that complies with Section 402 to the boarding and alighting area.

As noted above, these requirements apply to the extent that construction specifications are within the control of public entities; compliance is required to the maximum extent practicable. If a transit agency does not own the right-of way, but another public entity does own it, FTA encourages the transit agency to work with the public entity to come to an arrangement where a bus boarding and alighting area that complies with Section 810.2 to the maximum extent practicable is provided.
