Application Executive Summary

This grant includes \$82,299 in ARP Act - FY 2021 Section 5311 TTP formula funds, which is the full amount apportioned to the Sitka Tribe of Alaska. These funds will be used at 100% federal share for operating assistance, preventive maintenance, and indirect costs, to prevent, prepare for, and respond to the coronavirus pandemic. Operating assistance costs include, but are not limited to, driver and other operation workers' wages, salaries and benefits, fuel, items having a useful life of less than one year, personal protective equipment, and disinfecting supplies and equipment.

Purpose:

This funding will provide 2 years of operating assistance, preventive maintenance, and indirect costs, to maintain safe and reliable operations for the RIDE, Sitka Tribe of Alaska's transit program, for the time-period of 1/1/2022 to 12/31/2023.

Activities to be performed:

The funds will be used to cover eligible indirect costs, preventive maintenance, and operating expenses, including, but not limited to, driver and other operation workers' wages, salaries and benefits, fuel, items having a useful life of less than one year, personal protective equipment, and disinfecting supplies and equipment. The funds help to maintain safe and reliable transit operations and will assist the RIDE, Sitka Tribe of Alaska's transit program, in preventing, preparing for, and responding to the coronavirus pandemic.
