Application Executive Summary

This application to request FY2019 and FY2020 Section 5311 Tribal Transit Formula appointed to Cocopah Indian Tribe (CIT), Arizona, in the amount of \$64,828.

Purpose: The purpose of this application is to assist with operational funds for the daily operation of established transit service. Operational funds will include expenses needed for fuel costs for the remaining year of FY2019 & FY2020. Lastly, operational funds will be used for administration supplies/equipment for the newly constructed transit facility and assistance with the transit administration's operations. Capital funds will be used to acquire larger capacity vehicles to be used during heavy ridership periods and for routes with larger ridership to insure physical distancing and consolidate equipment and personnel. This grant request to continue to provide fixed route service to/from and within the Cocopah Indian Tribe (CIT) Reservation via the following services:

- Yuma County Intergovernmental Transportation Authority (YCIPTA), Yuma County Area Transit; Purple Route 6A - servicing North Cocopah Reservation to West Cocopah Reservation via East Cocopah Reservation and Avenue A (Monday thru Saturday.

Activities to be performed: This application will fund the operating cost to continue service of the Purple Route 6A, Rural Fixed Route;

- Monday thru Friday (6:57 a.m. to 6:30 pm), every 60 minutes
- Saturday (9:57 a.m. to 3:55 p.m.), every 120 minutes

The project is partially funded using 5311c Formula Grant funds.

The Cocopah Tribal Council wanted to find a way to connect the separate sections of three (3) reservations for the community members. In response to this a "Grey" route was established in March of 2005. The Grey Route only connected the East and West parts of the reservation to the Yuma business and recreational communities. As a result of the introduction of the Grey Route (March 2005), ridership increased significantly from twenty-five (25) passengers (per trip, per day) to one-hundred, and forty-five (145) passengers (per trip, per day). The Grey Route was re-designated as the Violet Route in January of 2012 and service was increased with hourly headways "All Day" Monday-Friday. Due to the successful use of the current route the Cocopah Indian Tribe (CIT) partnered with the Yuma Intergovernmental Public Transportation Authority (YCIPTA), as a result, the Violet Route was re-designated as the new and current Purple Route 6/6A - providing service to East, West, and North Reservation, to include a significant portion with neighboring communities.

Expected Outcomes: The outcomes of having this grant application approved will be to improve the Tribal Transit program by retaining employees and attracting qualified job applicants. This transport system contributes to the whole of government and community. In economic terms, it relates to the efficient movement of people to support the economic development of the Tribe. In social terms, it provides a safe transport system and provides accessibility and mobility to many of the tribal members that have disabilities. The environmental impact, reduces noise pollution and other pollutants to neighboring farms.

Intended Beneficiaries: The benefits of this grant award will improve the tribe Tribal Transit program by retaining employees and attracting qualified job applicants. The outcomes of having this grant application approved will be to improve the Tribal Transit Program by retaining employee and attracting a qualified pool of employees that do not have the available means of primary transportation. Awarding this grant will provide a reliable and timely mode of transport for Tribal members to have freedom of movement safely across the Reservation and provides an available platform for tribal members to have access to; medical/dental facilities, business and leisure activities, schools (primary and colleges), tribal enterprises and social events. Awarding this grant will also provide access for the community to have door-to-door access

to the Tribal Enterprises, which will generate economic growth and development.
