#### **Application Executive Summary**

This application is being made to request FY 2020 Section 5311 Tribal Transit Formula funds appointed to the Hopi Tribe, Arizona, in the amount of \$494,487.

This is to enhance and assist funding of public transportation on the Hopi Reservation and to provide transit services to the general public. Hopi Senom Transit provides the Hopi Reservation, Navajo Nation and surrounding non-tribal areas with affordable, accessible and reliable rural transportation. Our service consists of five routes and is operated five days a week, Monday through Friday, covering a 13-14 hour service period.

#### Purpose

The purpose of this application is to assist with Capital and Operating funds. Our Capital purchase will be a 30-passenger bus, Operating funds will be used for an additional Transit Driver, Fuel (gasoline & diesel), Preventative Maintenance, Vehicle Tires, PPE and General Operating Expenses. Funding will be provided at a 100-percent federal share with no local match required and will be available to support operating and other expenses generally eligible under Section 5311.

#### Activities to be Performed

The activities to be performed include purchase of a 30-passenger bus to be put into service on our Flagstaff Route, to create and hire an additional transit vehicle operator position and for assistance with rising Operating costs.

#### **Expected Outcomes**

Improvement of Hopi Senom Transit services with the addition of a 30-passenger bus to meet the increased demand for transit service to and from Flagstaff, AZ; adding a transit vehicle operator to address our driver shortage; and assistance to meet rising operating costs. All will increase reliability of service.

#### Intended Beneficiaries

Intended beneficiaries will be residents of the Hopi Reservation, a remote federally-recognized Native American tribe, and the general public of surrounding areas will benefit from increased transit services for employment, education, health care, shopping, essential and recreational travel. The bus and increase in staff and funds for Operating expenses will increase the quality and frequency of service and will make our service more reliable.

Subrecipient Activities: None

The following is a breakdown of costs that will be incurred with this grant award: 32-passenger bus, \$264,004; Driver Salary & Fringe: \$41,693; Fuel (Gasoline & Diesel): \$100,000; Preventative Maintenance: \$50,000; PPE: \$3,000; Tires: \$22,000; General Operating Costs: \$13,790.

The bus to be purchased is a 2022 Hometown View 31 Freightliner 6.7L Diesel 30 passenger with two wheelchair positions, a rear wheelchair lift, USB ports at each two-passenger seats, a 12V air purifier, 3-position bike rack and on-board camera security system. This bus will not replace any bus currently in service but will expand services to Flagstaff, Arizona.

#### **Project Description**

Scope 1: FY 2020 5311 Tribal Transit Formula funds in the amount of \$264,004 will be used to purchase a 2022 Hometown View 31' Freightliner 6.7L Chassis Diesel 30 passenger with two wheelchair positions, a rear wheelchair lift, USB ports at each two-passenger seats, a 12V air purifier, 3-position bike rack, a Safety Vision 8 on-board camera security system and Hanover front and side destination signs. This bus will not replace any bus currently in service but will expand our services to Flagstaff, Arizona.

Scope 2: FY 2020 5311 Tribal Transit Formula funds in the amount of \$230,483 will be used for public transportation costs, operating and maintenance costs of transit vehicles, equipment and enhancement of

existing services. There is no Local Match and the Hopi Tribe is exempt from Local Sales Tax. Total Cost: \$230,483.

#### **Project Benefits**

Public transit services are important to the Hopi Tribe and the scope of this project is to enhance and improve public transit service at a critical time for the Hopi Tribe. The November 2019 closure of the Navajo Generating Station power plant has resulted in the loss of an estimated 85 percent of the Hopi Tribe's source of income from coal sales from the Peabody Mine causing a severe impact on services provided by the Hopi Tribe. With the size and remoteness of the Hopi Reservation, US Census data shows that 17.9% of tribal residents do not have access to an automobile, and another 38% percent of households have only one vehicle available. With 34% of the Tribe's residents living below poverty level, many who have access to automobiles have difficulty keeping them maintained and fueled.

#### **Additional Information**

Hopi Senom Transit is a rapidly growing program: from 2014 to 2019, our services have increased 535 percent as we serve residents of the Hopi Reservation, the Navajo Nation and the general public. With the Tribe now focusing on economic development to replace this lost coal mining income, Hopi Senom Transit is now more than ever a valuable resource and important part of the Tribe's economy by providing transportation to Flagstaff, Arizona, for employment, job opportunities, job training and education as well as medical services, social services and essential shopping. Even with the COVID-19 pandemic entering its third year, continued growth in services and ridership is expected.

#### **Location Description**

The Hopi Tribe is a sovereign tribal nation located in northeastern Arizona. The Hopi Reservation occupies parts of Coconino and Navajo Counties encompassing more than 1.5 million acres at an elevation of 5,800 to 6,000 feet. The Hopi Tribe is made up of 12 Villages on three mesas located in four regions referred to as First Mesa, Second Mesa and Third Mesa. The Hopi trace their history back thousands of years, making them one of the oldest living cultures in with world with some of the Hopi Villages among the oldest continuously occupied settlements in the North American continent. The reservation occupies over 2,400 square miles in east north-central Arizona, 60 miles north of Winslow in Navajo County and 90 miles northeast of Flagstaff, northern Arizona's largest city. Although the trade area population exceeds 23,000, the Hopi Reservation population of approximately 7,000 creates a small market and limited labor pool. The reservation's isolation is intensified by political and social factors since it is completely surrounded by the Navajo Reservation and most commercial functions are supplied by off-reservation communities. The remoteness and expanse of Hopitutskwa (Hopi Land) has isolated the Hopi people from the outside world and has helped preserve the culture.
