Application Executive Summary

This application is to request FY2019 Section 5311 Tribal Transit Competitive funding appointed to Blue Lake Rancheria, California, in the amount of \$25,000.

The awards were announced in 2020, and thus do not lapse until 2022.

Purpose: The purpose of this application is to assist with updating the Blue Lake Rancheria's 2011 Transportation Plan. It is outdated and in vital need of being updated. The funding will be utilized by hiring a consultant/contractor to work on updating the tribe's transportation plan. It has been eleven (11) years since the plan was last updated from the 1997 plan. The transportation network on the Rancheria has changed considerably since 2011. Items needing series updates are; demographics, income, housing date, commute patterns, business operations, current land use, access of services, collision data and future land use. All of the listed items in need of updating are highly important to the community as it looks to it's future. This will be a long range plan, as determined by the tribe, on a ten-year cycle.

Activities to be Performed: The activity that will be performed during this grant performance period is the update of the Tribe's 2011 Transportation Plan.

Project Description

Updating of the Blue Lake Rancheria 2011 Tribal Transportation Plan is vital to the Blue Lake Rancheria as a community. This is a long range plan, as determined by the tribe, on a ten-year cycle. Transportation planning helps shape an area's economic health and quality of life. Not only does the transportation system provide for the mobility of people and goods, it also influences patterns of growth and economic activity by providing access to land. The performance of the system affects public policy concerns like air quality, environmental resource consumption, social equity, land use, urban growth, economic development, safety, and security. Transportation planning recognizes the critical links between transportation and other societal goals. The planning process is more than merely listing highway and transit capital projects. It requires developing strategies for operating, managing, maintaining, and financing the area's transportation system in such a way as to advance the area's long-term goal.

Project Benefits

An update to the 2011 Blue Lake Rancheria Transportation Plan would provide; -identification of weaknesses in the transportation system for both current and future demands -development of testing alternatives solutions to solve problems in the transportation system -information necessary on alternative strategies prior to selecting the most practical alternative for the community -allow development scenarios and compliments community-wide comprehensive land use -involve the whole community in the planning process as it belongs to the community -direction and desires to outside agencies, developers and businesses -an established base from which modifications can be made to reflect new trends/desires - support to a set of projects from which decision-makers can prioritize and choose for implementation.

Location Description

BLR is a federally recognized tribe located approximately six miles east of Highway 101 on State Highway 299, consists of approximately 91 acres of trust lands, and resides in the foothills of the Coastal Range of Humboldt County, in N. California. BLR is adjacent to the City of Blue Lake. Description of Transportation Modes and Areas Served: The BLR vehicular transportation network consists of several public streets on the Rancheria and adjacent to the Rancheria within the jurisdiction of the County of Humboldt/City of Blue Lake. The Casino/Hotel includes a parking lot, in which drive aisles form an important transportation component. Bike lanes have been installed on only one road adjacent to the Rancheria. Bike racks are available at the convenience store and hotel only. The BLR street network and adjoining area connections consists of long blocks and no paths or trails to allow pedestrians to travel in direct/short distances between destinations. Blue Lake Rancheria currently provides public transportation services via the Blue Lake Rancheria Transit System (BLRTS). BLRTS offers regular, fixed, deviated route services in excess of 200 miles per day since startup in 2000. Both transit and para-transit services are supplied. BLRTS gives at least 19,000 one-way rides per year. BLRTS connects to the Arcata, CA Transit hub, enabling passengers to connect to anywhere in the world. BLRTS service area for regular/deviated/fixed route

transit bus includes; Blue Lake Rancheria (population 203), adjacent City of Blue Lake (population 1,270) and outlying Humboldt County area of Glendale (population 7,085). The BLRTS connects to the intermodel hub in the City of Arcata (population 17,231). Total population served 25,569. According to Table 3 on page 14 of the 2011 Blue Lake Rancheria Transportation Plan, 3,000+ vehicles access the main entrance to the Casino and Hotel daily.
