Application Executive Summary

Purpose:

Fort Peck Tribes (FPT) will be using FY20 CARES ACT funding in the total amount of \$422,586 (full apportionment). This grant utilizes CARES Act funding to prevent, prepare for, and respond to COVID-19. Per the CARES Act, the grant requests 100% federal share.

Activities to be performed:

These funds will be used to rehab/renovate the main facility, cover costs for PM, and purchase support equipment for Fort Peck Tribal Transit Program.

The grant scope of work includes the following:

1. Facility-related capital (rehab/Renovate FPT main transit facility)

2. Capital (facility support equipment)

3. Preventive Maintenance (vehicle and equipment)

The total estimated cost to renovate the main facility will be \$1,238,200. This funding will be used in conjunction with funding from FY20/21 5311 TTP formula funds in MT-2022-026-00 to cover total cost of this project.
