### Application Executive Summary

This grant includes \$430,660 in CRRSAA FY 2021 Section 5311 TTP formula funds, which is the full amount allocated to the Spokane Tribe of the Spokane Reservation. These funds will be used at 100% federal share for operating assistance, preventive maintenance, the purchase of approximately two (2) replacement buses, and indirect costs to prevent, respond to, and recover from the COVID-19 pandemic. Operating assistance costs include, but are not limited to: driver and other operation worker's salaries and benefits; fuel; items having a useful life of less than one year; safety equipment for vehicles; disinfectants equipment, supplies and services; personal protective equipment for staff, drivers, and riders, and administrative leave.

### Purpose:

The purpose of this award is to provide 3 years of operating assistance, preventive maintenance, and project administration (indirect costs) for the time-period of 10/1/2021 to 9/30/2024, and to purchase approximately two (2) replacement buses.

### Activities to be performed:

Operating assistance, project administration through the use of a federally approved indirect cost rate, and the purchase of approximately two (2) replacement buses to maintain safe and reliable operations of the Moccasin Express transit service.

### Expected Outcomes:

Maintain safe and reliable transit service which includes access to medical services, social services, education, employment, recreation, and cultural activities.

### Intended Beneficiaries:
