# DOE's Core Mandate



Work on behalf of the program claimants to ensure that all available facility records and data are provided to DOL, NIOSH, and the Advisory Boards.



### DOE Responsibilities

Respond	Respond via the Secure Electronics Records Transfer <b>(SERT)</b> System to DOL and NIOSH requests for information related to individual claims (employment verification, exposure records).	
Assist	Provide support and assistance to DOL, NIOSH, and Advisory Board on large-scale research and site characterization projects through records research and retrieval efforts at various DOE sites.	
Conduct	Conduct research, in coordination with DOL and NIOSH, on issues related to covered facilities designations, and website	

### EHSS Clicco/Instrument, Harlith, Saldayand Security

#### Examples:

- Employment history for individual workers;
- Group and individual worker-monitoring data;
- Workplace area-monitoring data;
- Process description information and process history;
- Incident, safety, and accident reports;
- Pertinent excerpts from employee medical records;
- Information on the quantity and composition of toxic substances; and
- Identification, last known address, phone numbers of current and former supervisors, occupational safety and health staff, and nonsupervisory employees of DOE and its contractors and subcontractors with expertise on site operations

# Individual Records



- Claimants often worked at multiple DOE sites, for multiple contractors and subcontractors, and in different jobs or divisions over a career.
- For a typical request for a worker's records, DOE may have to go to many different site departments and within those departments many different records sources or databases.
- For example, one DOE site routinely checks approximately 40 different sources for responsive records, including hardcopy paper records, microfilm, microfiche, databases, and scanned electronic records.



- DOE funded Former Worker Program since 1998, screening employees of 12 DOE sites
- Managed by Barry Commoner Center for Health and the Environment, Queens College, City University of New York (CUNY)

#### Worker Health Protection Program (WHPP)

#### Nevada Test Site Screening

- We offer no-cost medical screenings for health effects due to exposure to asbestos, silica, beryllium, noise, solvents, and other hazardous chemicals.
- Tests may include: physical exam, chest x-ray with b-read, breathing test, blood test, spirometry, beryllium test, and audiology. Participants are eligible for rescreen exams every 3 years.
- Participants at the highest risk of lung cancer (based on age, work history, and smoking history) are invited to receive Low Dose CT Scans from the WHPP Early Lung Cancer Detection Program (ELCD)

#### **Program Details:**

- Former (not current) workers with one year at the NTS, including North Las Vegas, Losee Road, Sunset Road, Tonopah Test Range, and Nuclear Rocket Development Station (NRDS).
- Screenings held at UNLV School of Medicine's Department of Family and Community Medicine

#### What we've done in Nevada:

Former workers screened: <u>5,679</u> Exams (including re-screens): <u>10,096</u> Former NTS workers screened for lung cancer: <u>760</u> Low-dose CT scans completed: <u>2,875</u> Worker Health Protection Program (WHPP)
