viable alternatives to child labor; and

Prevent a further 15,000 at-risk children from prematurely entering the labor market.

Promoted the establishment of effective legislation to prevent hazardous child labor on plantations;

Sensitized employers, workers and community organizations through awareness-raising campaigns;

Provided services and alternatives to working children and children at risk of working, and their families: and

Provided health care, formal and non-formal education, and vocational training, to former child
