**ORDER GRANTING SUMMARY PROBATION**

ALL CASES: Defendant shall obey all FEDERAL, STATE, COUNTY, AND CITY LAWS.

**DUI and Suspended/Revoked Licenses:**

- Defendant shall not drive a motor vehicle without a valid driver's license in possession.
- Defendant shall not drive a motor vehicle unless covered by insurance for public liability.
- Defendant shall not drive a motor vehicle with any detectable amount of alcohol in his/her system.
- Defendant shall enroll in the Alcohol Safety Class or SS 38 program within ten days.

- Driver's license restricted for \_\_\_\_\_ as follows: Drive to and from employment, during course of employment, and to and from treatment program.
- Shall submit to blood or breath test upon request of Peace Officer to determine alcohol content in system while driving.
- Shall submit to field sobriety test if operating a motor vehicle, upon request of Peace Officer.

**Drug Related Cases:**

- Defendant shall not take any form of controlled drugs or narcotics unless prescribed by a person licensed to prescribe them by the State of California.
- Defendant must submit his/her person, vehicle, and place of residence to a search for and or seizure of narcotics, drugs or other contraband at any time of day or night, without a search warrant.
- Defendant shall register as a narcotic offender pursuant to 11590 H&S.
- Shall submit to blood, breath or urine test upon request of Peace Officer, to determine whether or not he/she has drugs or narcotics in his/her system.
- Defendant shall not be in possession of any restricted drugs and or paraphernalia.
- Defendant shall not associate with any known drug users or sellers.

**Custody:**
