## Effective October 1, 2015

- The Division of Energy Employees Occupational Illness Compensation (DEEOIC) Medical Benefits Identification Card (MBIC) has been redesigned. Due to changes in government billing requirements and to better protect the privacy and the confidentiality to our claimants, covered medical conditions are no longer displayed.
- Entitlement to medical benefits for the treatment and care of our claimants' accepted medical condition(s) has *NOT* changed due to the redesign of the MBIC.

# New Medical Benefits Identification Card - Back

1. *This card is the property of the U.S. Government and its counterfeiting, alteration or misuse is a violation of Section 499, Title 18, U.S. Code.*
2. *Carry the card with you at all times and show it to your doctor, clinic, pharmacist or hospital when you are in need of medical services for your accepted condition(s).*
3. *Medical treatment authorized under the Energy Employees Occupational Illness Compensation Program Act is paid for by the U.S. Department of Labor. Call toll free (866) 272-2682 for specific information.*
4. *All bills should be submitted to the Energy Employees Occupational Illness Compensation Program, P.O. Box 8304, London, KY 40742-8304.*
5. *If found, drop in mailbox. Postmaster: Postage guaranteed. Return to: Energy Employees Occupational Illness Compensation Program, P.O. Box 8304, London, KY 40742-8304.*
6. *When using the DOL OWCP website (<http://owcp.dol.acs-inc.com/>) to request an authorization for medical services or to verify eligibility, your doctor must use the Card ID number located on the front of the card. Claimants can use this card ID number to access the DOL OWCP website.*

## **Information About the New MBIC**

- **The MBIC includes a 10-digit card ID number, the Benefits Identification Number (BIN) and DEEOIC Group ID for pharmacy point of sale submissions.**
- **No co-pay or deductible is required for services rendered to claimants.**
- **The back of the new MBIC includes the address to submit bills.**

## **Verifying Eligibility and Coverage**

- **Enrolled Providers can access the website by entering the claimant's 10-digit card ID number located on the front of the card, and in the field labeled "Case File Number," the claimant's social security number.**
