### **Major Completed Actions (Short bulleted list of the major actions taken to date.)**

#### **Employment and Training Administration (ETA)**

The Emergency Unemployment Compensation (EUC) program, the Federal Additional Compensation (FAC) program, and Extended Benefits (EB) provisions begin to phase out on June 2, 2010. ETA will continue to monitor Congressional activities related to additional EUC extensions. Given that Congress did not act on unemployment extensions prior to leaving for the Memorial Day recess, the week ending May 29 was the last week of unemployment for which an individual could establish eligibility for EUC. In the case Congress acts after recess, the provisions will be made retroactive.

Federal law currently provides for 100% Federal sharing for benefit costs under the Federal-State EB program for weeks of unemployment beginning before June 2, 2010. As a result, states that have linked the expiration of their EB Total Unemployment Rate (TUR) trigger to the termination of 100% Federal sharing for EB have had or will soon have their triggers end and may soon cease to be in an EB period.

Absent additional state or Federal enactments, the following changes will take place in the coming weeks:

- The following states had their TUR trigger expire on May 8, and will have their EB payable period conclude on June 5, 2010: Alabama, Colorado, Delaware, Florida, Idaho, Indiana, Kentucky, Missouri, Ohio, Pennsylvania, South Carolina, Tennessee, Texas, and West Virginia.
- New York had its TUR trigger expire on May 9, and will have its EB payable period conclude on June 6, 2010.
- The following states had their TUR trigger expire on May 15, and will have their EB payable period conclude on June 12, 2010: Arizona, California, the District of Columbia, Georgia, Illinois, Maine, Nevada, Virginia, and Wisconsin. NOTE: Georgia disagrees with our projected end date, and we are working with SOL to resolve this issue.
- Massachusetts had its TUR trigger expire on May 29, and will have its EB payable period conclude on June 26, 2010.
- Michigan will have its TUR trigger expire on June 5, and will have its EB payable period conclude on July 3, 2010.

The Recovery Act provided for a special distribution of \$7 billion in Unemployment Insurance (UI) modernization incentive payments to states. Rhode Island's 1/3 share of its UI Modernization incentive payment is under review.

ETA continues to make determinations for petitions submitted since the 2009 Trade Adjustment Assistance amendments mandated in the Recovery Act which took effect on May 18, 2009. As of May 28, 2010, 3,823 determinations have been made on cases received under the 2009 Amendments.

The closing date for Recovery Act-funded National Emergency Grants On-the-Job Training (OJT) applications was May 24, 2010.

The applications are currently under review. The funds must be awarded by June 30.

The Health Care Virtual Career Platform Solicitation for Grant Applications closed on May 7, 2010. Review of these applications is underway and an announcement of the Recovery Act-funded grants is expected in mid-June.

#### **Employee Benefits Security Administration (EBSA)**



**Major Planned Actions (Short bulleted list of the major planned actions)**

The Philadelphia Regional Office will convene the Reemployment NOW! Conference scheduled for June 8-9, 2010 in Philadelphia, PA. This event will provide the latest information available on economic changes, emerging industries and occupations and reemployment service strategies. The conference will target a diverse workforce development audience. Recovery Act contributions to expanding workforce services will be touched on in various sessions. A session on partnering with Temporary Assistance to Needy Families (TANF) will highlight practices in subsidized employment supported by Recovery Act Emergency Contingency funds awarded through the Administration for Children and Families.

Atlanta Regional Office staff will participate in a Recovery Act Interagency Workgroup activity in Asheville, North Carolina on June 9-10, 2010. The group's focus is revitalization and sustainable communities.

The San Francisco Regional Office will hold a Recovery Act Green Jobs/Health Care and Emerging Industries New Grantee Post-Award Forum on June 15-16, 2010 in the San Francisco Bay area.

The Philadelphia Regional Office and National Office staff, along with leadership from the District of Columbia Department of Employment Services continues to provide technical assistance on the implementation of the District of Columbia's Summer Youth Employment Program. The District is expected to begin its summer program on June 28, 2010, enrolling 1,500 Recovery Act-funded youth in addition to approximately 21,000 youth served through other funding. The technical assistance includes implementing processes to train supervisors, develop youth policies and procedures including a focus on youth eligibility, and developing a workforce readiness tool.
