**Notice of Endangered Status  
For  
Plumbers & Pipefitters Local Union No. 9 Pension Plan**

This is to inform you that on September 27, 2013 the plan actuary certified to the U.S. Department of the Treasury, and also the Board of Trustees, that the Plumbers & Pipefitters Local Union No. 9 Pension Plan is in endangered status for the plan year beginning July 1, 2013. Federal law requires that you receive this notice.

Background

The Pension Protection Act of 2006 ("PPA") imposes new rules on all single employer and multiemployer defined benefit pension plans intended to improve their funding status (the Local 9 Pension Plan is a multiemployer plan). The law has established three zones for plans with funding problems – endangered, seriously endangered, and critical. A plan is in endangered status if it is less than 80% funded or the plan is projected to have a funding deficiency within 7 years. A plan is in seriously endangered status if it is less than 80% funded and the plan is projected to have a funding deficiency within 7 years. A plan is in critical status if (1) it is less than 65% funded and with a projected funding deficiency within 5 years, or the inability to pay benefits within 7 years, or (2) it has a projected funding deficiency within 4 years, or an inability to pay benefits within 5 years, regardless of its funded percentage, or (3) it has benefits for inactive that are greater than for actives, contributions that are less than carrying cost and a funding deficiency projected within 5 years.

Endangered Status

The Plumbers & Pipefitters Local Union No. 9 Pension Plan is considered to be in endangered status because its funded percentage is less than 80%. More specifically, the plan's actuary has determined that the plan's funded percentage was 72% as of July 1, 2013 representing an increase of more than 3% over the prior year based on prudent and responsible decisions of your union and employer Trustees.

Funding Improvement Plan

Federal law requires pension plans in endangered status to adopt a Funding Improvement Plan (FIP) aimed at restoring the financial health of the plan. On March 3, 2011, the Plan Trustees adopted a Rehabilitation Plan that provided for an increase in the hourly employer contribution rate from \$8.47 to \$9.85, effective July 1, 2011, and a change in the eligibility requirements for a supplemental pension from (a) 25 years credit to (b) age last birthday plus credited service equals at least 90, effective July 1, 2011. The Rehabilitation Plan is intended to satisfy the requirements of a Funding Improvement Plan and it will remain in place unless it is determined later this year that a new Funding Improvement Plan is required.
