Plan Status Endangered for the plan year beginning May 1, 2009 if no Section 204 election were made

This is to inform you that an election was made by the Plan Sponsor on July 29, 2009 under section 204 of WRERA to treat the Plan as endangered for the plan year beginning on May 1, 2009. This election applies only for the current plan year. If the Plan is certified to be in endangered, seriously endangered or critical status for the plan year beginning May 1, 2010, the Plan Sponsor will provide you notice of the Plan's status (i.e. endangered, seriously endangered or critical) for that following year and steps will have to be taken to improve the Plan's funded situation, which steps may include increases in contributions and reductions in future benefit accruals.

The Plan Sponsor also made an election on July 29, 2009 under section 205 of WRERA to extend the funding improvement period from 10 years to 13 years.

Notice of Endangered Status For

Plumbers and Pipefitters Local 152 Pension Fund

This is to inform you that on July 28, 2009 the Plan actuary certified to the U. S. Department of the Treasury, and also to the Plan sponsor, that the Plan is in endangered status for the plan year beginning May 1, 2009. Federal law requires that you receive this notice.

Endangered Status

The Plan is considered to be in endangered status because it has a funding problem. More specifically, the Plan's actuary determined that the Plan's funded percentage as of May 1, 2009 is less than 80%.

Funding Improvement Plan

Federal law requires pension plans in endangered status to adopt a funding improvement plan aimed at improving the financial health of the Plan over ten years. Since the Plan was endangered last year, a funding improvement plan was adopted July 30, 2008. As part of the Funding Improvement Plan, the Plan applied for and received approval for a 5-year automatic extension of the charge bases as detailed in the April 17, 2009 notice.
