

# LABORERS LOCAL 1000 PENSION FUND

This is to inform you that on September 28, 2016 the Laborers Local 1000 Pension Fund's actuary certified to the U.S. Department of the Treasury, and also to the plan sponsor, that the plan will be in critical and declining status for the plan year beginning July 1, 2016. Federal law requires that you receive this notice.

## **Critical Status**

The plan is considered to be in critical status because it has funding or liquidity problems, or both. More specifically, the Laborers Local 1000 Pension Fund's (Pension Fund) actuary determined that the Pension Fund is less than 65% funded, projected to potentially have an accumulated funding deficiency in the current year and is projected to become insolvent in the succeeding fourteen year period based on the Reasonable Measures Rehabilitation Plan adopted by the Trustees.

## **Rehabilitation Plan and Possibility of Reduction in Benefits**

Federal law requires pension plans in critical and declining status to adopt a rehabilitation plan aimed at restoring the financial health of the Pension Fund. The law permits pension plans to reduce, or even eliminate, benefits called "adjustable benefits" as part of a rehabilitation plan. If the trustees of the Pension Fund determine that additional benefit reductions are necessary, you will receive a separate notice in the future identifying and explaining the effect of those reductions. Any reduction of adjustable benefits will not reduce the level of a participant's basic benefit payable at normal retirement. In addition, any additional reductions may only apply to participants and beneficiaries whose benefit commencement date is on or after October 31, 2016. But you should know that whether or not the plan reduces adjustable benefits in the future, effective as of November 1, 2016 the Pension Fund is not permitted to pay lump sum benefits (or any other payment in excess of the monthly amount paid under a single life annuity) while it is in critical status. The Trustees previously adopted a Reasonable Measures Rehabilitation Plan aimed at forestalling insolvency that included both future contribution increases and future benefit modifications.

## **Rehabilitation Plan**

Federal law requires pension plans in critical status to adopt a rehabilitation plan aimed at restoring the financial health of the Pension Fund. The law permits pension plans to reduce, or even eliminate, benefits called "adjustable benefits" as part of a rehabilitation plan. If the trustees of the Pension Fund determine that additional benefit reductions are necessary, you will receive a separate notice in the future identifying and explaining the effect of those reductions. Any reduction of adjustable benefits (other than a repeal of a recent benefit increase) will not reduce the level of a participant's basic benefit payable at normal retirement. In addition, any additional reductions may only apply to participants and beneficiaries whose benefit commencement date is on or after October 31, 2016. The Trustees did previously adopt a Reasonable Measure Rehabilitation Plan implementing both future contribution increases and future benefit modifications.

## **Adjustable Benefits**

The Pension Fund offers the following adjustable benefits which may be reduced or eliminated as part of any rehabilitation plan the Pension Fund may adopt:

- Early retirement or Disability benefits or any retirement-type subsidy;
- Benefit payment options other than a qualified joint-and survivor annuity (QJSA);

## **Employer Surcharge**

The law requires that all contributing employers pay to the Pension Fund a surcharge to help correct the Fund's financial situation until a Rehabilitation Plan is adopted. The amount of the surcharge is equal to a percentage of the amount an employer is otherwise required to contribute to the Pension Fund under the applicable collective bargaining agreement. With some exceptions, a 5% surcharge would be applicable in the initial critical year and a 10% surcharge is applicable for each succeeding plan year thereafter in which the plan is both in critical status and has not adopted a Rehabilitation Plan.
