

Notice of Critical Status
For
Toledo Roofers Local No. 134 Pension Plan

This is to inform you that on March 31, 2026 the Plan Actuary certified to the U.S. Department of the Treasury and to the Plan Sponsor that the Plan is in critical status for the plan year beginning January 1, 2026. Federal law requires that you receive this notice. In the future you will receive an annual update of this status and the progress the Plan is making towards the goals described below.

Critical Status

The Plan is still considered to be in critical status because it is projected to satisfy the following:

Receipt of Special Financial Assistance:

The Plan was approved an application for Special Financial Assistance under the American Rescue Plan Act. As a condition for receiving Special Financial Assistance, the Plan is considered to be in critical status through 2051.

As required by law, the Plan Actuary's certification includes only contribution rate increases that have been codified in collective bargaining or participation agreements.

Rehabilitation Plan and Possibility of Reduction in Benefits

Federal law requires pension plans in critical status to adopt a rehabilitation plan aimed at restoring the financial health of the Plan. A rehabilitation plan may involve reductions to future benefit accruals, increases to contribution rates, or both. The law also permits pension plans to reduce, or even eliminate, benefits called "adjustable benefits" as part of a rehabilitation plan.

As of August 7, 2017, certain benefits were reduced pursuant to the rehabilitation plan, and you were mailed a notice of these reductions on December 29, 2017. As of July 1, 2018, additional benefits were reduced pursuant to the rehabilitation plan, and you were mailed a notice of these additional changes on June 1, 2018. The current rehabilitation plan does indicate that all reasonable measures have been taken. Additionally, effective April 1, 2019, most benefits were reduced as outlined in the June 25, 2018 application for suspension of benefits under the Multiemployer Pension Relief Act of 2014. Disabled participants and their beneficiaries and retired participants and beneficiaries age 80 by the end of April 2019 were fully protected from this reduction. Retired participants and beneficiaries age 75 by the end of April 2019 were partly protected. All benefit protections were required by law. Refer to the notice that was mailed to you on June 29, 2018 for more information on how this benefit reduction has affected your benefit. On December 22, 2023, the Plan's application for Special Financial Assistance was approved. Upon approval, the previously suspended benefits discussed above were reinstated effective January 1, 2023. You should have received a separate notice detailing how this has affected your benefit. Also, the Plan is not permitted to pay any lump sum benefits in excess of \$5,000 (or any other payment in excess of the monthly amount paid under a single life annuity) while it is in critical status.

Future Experience and Possible Adjustments

The rehabilitation plan is based on a number of assumptions about future experience and may need to be adjusted in the future if such assumptions are not met. Additional contribution rate increases and/or reductions in the rate at which benefits are earned may be needed if the Fund were to suffer asset returns below the expected 7.50% (in the 2026 plan year or later), a drop in the hours worked, or poor experience from other sources. If, at some point in time, the Trustees determine that further adjustments are necessary, you will receive a separate notice identifying and explaining the effect of those changes.
