2008 Plan Year Status

For the Plan Year commencing February 1, 2008 and ending January 31, 2009 the Fund Actuary certified the Fund to be in Green Zone (neither Endangered nor Critical) status.

2009 Plan Year Status

For the Plan Year commencing February 1, 2009 and ending January 31, 2010 the Fund Actuary certified the Fund to be in Yellow Zone (Endangered) status.

Election to Retain 2008 Plan Year Status

Pursuant to Section 204(a) of the Worker, Retiree and Employer Recovery Act of 2008 (WRERA), the Board of Trustees has elected to retain the Fund's 2008 Green Zone status for the 2009 Plan Year.

Should the Fund be certified in Endangered or Critical status for the 2010 Plan Year, notice of that status will be provided, and steps may have to be taken to improve the funded status. It is anticipated, but cannot be assured, that the April 1, 2009 reduction in the Fund's future benefit accrual rate will avoid the need for further action.
