**NOTICE OF WRERA ELECTION  
FOR  
UNITE HERE LOCAL 25 AND HOTEL ASSOCIATION OF WASHINGTON, DC PENSION PLAN**

Introduction

This notice is being provided pursuant to Section 204(c)(2)(A)(ii) of the Worker, Retiree, and Employer Recovery Act of 2008 (WRERA) to inform you of an election made by the Trustees to maintain for the 2009 plan year the same multi-employer funding status as was certified to during the 2008 plan year.

Election Information

The Trustees have made an election under Section 204 of WRERA to treat the plan as being neither in endangered nor critical status for the plan year beginning on January 1, 2009. Absent this election, the plan would have been Endangered, as certified by the plan's actuary this year.

Please note that this election applies only for the current plan year and that, if the plan is certified to be in endangered or critical status for the plan year beginning January 1, 2010, you will be provided notice of the plan's status for that year and steps will have to be taken to improve the plan's funded situation, which steps may include increases in contributions and reductions in future benefit accruals.
