Re: Interim Final Rule for Group Health Plans and Health Insurance Coverage Relating to Status as a Grandfathered Health Plan Under the Patient Protection and Affordable Care Act

I believe the consumer protections included as part of the new health care law are vitally important and should be extended to as many people as possible. The triggers or conditions that would extend these protections to consumers under currently existing "grandfathered" plans should not be weakened or reduced in any way.
