Re: Fiduciary Duties Regarding Proxy Voting and Shareholder Rights
Proposed Regulation (RIN 1210-AB91)

Dear Director Canary:

On behalf of the Principles for Responsible Investment (PRI),¹ I am writing to request an extension of the comment period from 30 days to 90 days for public comments on the notice of proposed rulemaking entitled “Fiduciary Duties Regarding Proxy Voting and Shareholder Rights Proposed Regulation” (“Proposal”).² The Employee Benefits Security Administration (“EBSA”) announced its proposed regulation on August 31, 2020.

Signatories to the PRI are committed to integrating all financially material factors, including ESG factors, into their investment processes. This is a risk management strategy aimed at integrating factors such as climate change and human capital management that evidence shows have a material economic impact on asset prices, especially when taking into account the risks that universal investors face.

The Proposal adds a number of onerous obligations on ERISA fiduciaries which could increase costs to American retirement savers. The shareholder proposal process is a core part of an investor’s fiduciary duty. We encourage the DOL to provide additional opportunities and time to collect information to ensure that the Department and practitioners have a shared understanding of the impact of the rule and how plan fiduciaries will be required to act in response to it. Signatories to the PRI have taken a strong interest in submitting comments on the Proposal. The Proposal makes

“major additions to the Investment duties regulation”³ and we are concerned that 30 days is insufficient due to pandemic-related productivity challenges, economic challenges, and asset price volatility that asset owners and investors are trying to manage. We believe that 90 days will provide a reasonable opportunity for interested parties to submit comments.
