Webinar on Health Care Coverage and Retirement Benefits
After Job Loss**

This webinar is for employees who recently lost their jobs and have questions about their health coverage or their 401(k)/pension plans. You may have rights to certain health and retirement benefit protections even if you lose your job. If your company provided a group health plan, you may be entitled to continued health benefits for a period of time after losing your job. You may also have more affordable or more generous options for health coverage available to you and your family through other group health plan coverage, such as through a spouse's plan, the individual Marketplace and certain governmental programs. This webinar will also explain how job loss affects retirement benefits. Knowing your rights can help you protect yourself and your family until you are working full time again.

The Employee Benefits Security Administration (EBSA) will discuss your rights to health coverage under the Consolidated Omnibus Budget Reconciliation Act (commonly known as COBRA), the Health Insurance Portability and Accountability Act (commonly known as HIPAA), and the Affordable Care Act. In addition, EBSA will discuss the rights of participants in an employer sponsored retirement plan under the Employee Retirement Income Security Act.

EBSA's Benefit Advisors will be available to address your specific questions. The webinar will be offered on different dates. Each session lasts about 60 minutes and is limited to 200 participants.
