ADDITIONAL COMMENTS:

lowa continues to provide service delivery to priority populations who generally have the most barriers to employment and are difficult to serve. During this reporting period, 98% of lowa's WIOA Title I Adult participants receiving individualized career and training services were recipients of public assistance, low-income, or basic skills deficient. While lowa exceeded its performance goals in all areas, there was a significant increase in median earnings which can be attributed to the state's focus on training and improved career planning. It should be noted

that enrollments were down 15% compared to program year 2022 which can be attributed to Iowa's low unemployment rate and the realignment of four local areas into one effective 7/1/2023. The

realignment resulted in the loss of service provider staff leading up to the transition and the hiring and training of new staff during the transition period leading to a lack of outreach and follow-up with enrolled participants. Iowa's focus for program year 2024 is ongoing training on data integrity, the accurate recording of performance outcomes, career planning, outreach, and follow-up.
